#### **ORDER**

WHEREAS, Dr. Shashi Bhusan Institute of Education, Lakshirbond, Boalipar Bazar, Hailakhandi, Assam-788155 was granted recognition for B.Ed. Course with an intake of 50 vide ERC Order No. ERC/7-19/2001/1657 dated 15.06.2001 from the academic session 2001-2002, followed by revised recognition order No. 31941 dt. 23.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> meeting held on 27<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-275.14.46/(AS-S/N-21/97)/B.Ed./2019/61424 dated 28.08.2019 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 05.02.2020. The Appellate Authority vide its Order No. 89-37/E-153626/2020 Appeal/10<sup>th</sup> Mtg.-2020/22<sup>nd</sup> July, 2020/92988 dated 15.09.2020 decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order, details of faculty appointed with the approval of affiliating body. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020 and the committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 50 students (01 unit) to be issued.

- 5. NOW THEREFORE, recognition withdrawn vide order dated 05.02.2020 to the institution viz. Dr. Shashi Bhusan Institute of Education, Lakshirbond, Boalipar Bazar, Hailakhandi, Assam-788155 for B.Ed. course is hereby restored recognition with an annual intake of 50 students (01 unit).
- 6. The terms and conditions of the order F. ERC/NCTE/(AS-S/N-21/97)/B.Ed./(Revised Order)/2015/31941 dt. 23.05.2015 issued to the institution shall remain same.
