ORDER

Change of Premises of the Institution

WHEREAS, Anath Bandhu Angurbala Teacher's Training Institute, Plot No- 649, 650, 651, 627, 640, St No- NH 41, Vill- Osmanpur, PO- Chaknan, Tehsil/Taluka- Chandipur, Town/City- Chandipur, Dist- Midnapore, West Bengal- 721633 (Code No. ERCAPP2289 & ERCAPP2290) granted recognition for conducting B.Ed. & D.El.Ed. course with an annual intake of 100 (Two Basic Units) vide order No. 52975 dated 02.5.2017 and vide order No. 53043 dated 02.5.2017, respectively as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the aforesaid institution had submitting application dated 22.02.2021 and 26.02.2021 for shifting of premises along with requisite documents.

3. **AND WHEREAS**, the ERC in its 292nd meeting held on 20th April, 2021 considered the application for shifting of premises and decided “**VT to be constituted under section 14 of the NCTE Act, 1993 to ascertain infrastructure and instructional facilities of the TEI for shifting of premises to the new address as mentioned in the shifting application.**” Anath Bandhu Angurbala Teachers Training Institute, Bhutanathdham, Garhbari, P.O.-Nazir Bazar, P.S.-Bhupatinagar, Dist.-Purba Medinipur, West Bengal- 721655, and decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 08.07.2021 & 09.07.2021 and Visiting Team Report received at ERC, NCTE on 13.07.2021.

4. **AND WHEREAS**, the ERC in its 300th meeting held on 28th December, 2021 after considering and examining the application along with the documents submitted by the institution including Norms and Standards, guidelines received from NCTE Hqrs. from time to time and VTR for shifting of premises, discussed the matter in detail and decided to SCN as under:

- The address of institution such as P.S. Chandipur mentioned in the building plan attached with VT report, which mismatch with P.S. Bhupatinagar as per shifting application and Building completion certificate. P.S. is shown blank applying white correction fluid on the building plan attached with shifting application. The correct information on the exact location/complete address of shifting of premises is to be submitted.
- Built up area is not mentioned in the approved building plan attached with VT report.
- Building safety certificate from the competent authority is not submitted.
