ORDER

Change of Premises of the Institution

WHEREAS, Panskura Teachers Training Institute, Panskura Vidyasagar Social Welfare Society Building, Vill.- Kanakpur, Po.-Naranda, Dist.-Purba Medinipur, West Bengal-721139 (Code No. APE00573) had granted recognition for conducting B.Ed. course with an annual intake of 100 (Two Basic Units) vide order No. 4070 dated 17.05.2010, followed by revised order issued vide order No. 32487 dated 30.05.2015 as per NCTE Regulation, 2014.


2. **AND WHEREAS**, the aforesaid institution had submitting application dated 07.07.2020 for change of name and shifting of premises along with requisite documents.

3. **AND WHEREAS**, the ERC in its 290th (Part - 2) meeting held on 04th March, 2021 considered the application for shifting of premises and decided “**The change of name of the college from ‘Ratulua Secondary Teachers Training Institute’ to ‘Panskura Teachers Training Institute’ is accepted.**” and VT to be constituted under section 14 of the NCTE Act, 1993 to ascertain infrastructure and instructional facilities of the TEI for shifting of premises to the new address as mentioned in the shifting application.” decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 11.12.2021 & 12.12.2021 and Visiting Team Report received at ERC, NCTE on 27.12.2021.

4. **AND WHEREAS**, the ERC in its 300th meeting held on 28th December, 2021 after considering and examining the application along with the documents submitted by the institution including Norms and Standards, guidelines received from NCTE Hqrs. from time to time and VTR for shifting of premises, discussed the matter in detail and decided as under:

“The institution is still deficient on the following in light of NCTE Regulations, 2014 agenda note, NCTE Act, NCTE Regulations 2014.”

- Number of titles in library is less than required as per NCTE norms.
- The library is shared for both B.Ed. and D.El.Ed. courses. Seating capacity in the library is less than required as per NCTE norms.
- Building safety certificate from the competent authority is not submitted.
- A certificate to the effect that the institutional campus, building furniture is disabled friendly as per the persons with disability (PWD) and of the Govt. of India is not submitted.

5. **AND WHEREAS**, the ERC in its 302nd meeting held on 28th – 01st March, 2022 after considering the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and allowed **the shifting of the premises.**

6. **NOW THEREFORE**, permission is granted for shifting the institution from “Panskura Teachers Training Institute, Panskura Vidyasagar Social Welfare Society Building, Vill.- Kanakpur, Po.-Naranda, Dist.-Purba Medinipur, West Bengal-721139” to “Panskura Teachers Training Institute, At the Building of Panskura Primary Teachers Training Institute, Plot No.-388, 389, 390, 391, 393 & 3165 (Part), Vill.-Kanakpur, P.O.-Naranda, P.S.- Panskura, Dist.- Purba Medinipur, West Bengal – 721139”. [Formerly: Ratulia Secondary Teachers Training Institute]. Now, the institution may be run at the aforesaid address henceforth from the date of issue of this order.
