- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
4. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the institution, details of the programme applied for with intake; availability of physical infrastructure, such as land, buildings, classrooms and other facilities or amenities; instructional facilities, such as computer lab, library and the particulars of their proposed teaching faculty and non-teaching staff, with photographs, for information of all concerned.  - 4. Details of the students admitted during the current session along with qualification, marks in the qualifying examination and in the entrance test, if any, etc.;
 - 5. Details of the students;
 - 6. Details of the physical facilities;
 - 7. Details of the library, journals subscribed to, and additions, if any, in the last quarter;
 - 8. Details of the information submitted along with application;
 - 9. Details of the post additional relevant information, if it so desires.
- Information on its website shall render the institution liable for



8. The institution shall make available list of students admitted on its official website.
9. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.


