#### **ORDER**

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, the recognition was granted to Dulari Institute of Education Centre, Vill:- Manika Bishnunpur Chand, Street / Road:-Pusa Road, Taluka/ Mandal:- Mushahari, Town/City:- Manika Bishnunpur Chand, Dist:- Muzaffarpur, Bihar-843119 for conducting B.Ed. programme of two year duration with an annual intake 100 (two basic units) vide Order No. F. No. ERC/243.6.12/B.El.Ed. & B.Ed./2017/Appl. Code No. ERCAPP201645176 Appl. ID. No. 9405/54620 dated 07.10.2017 from the academic session 2018-2019, as per NCTE Regulations, 2014.

- 2. AND WHEREAS, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284<sup>th</sup> meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the Show Cause Notice to the institutions which have been recognized without NET qualified teachers. Accordingly, SCN was issued to the institution on dated 28.09.2020. The reply of the institution was received in ERC on 25.11.2020.
- 3. AND WHEREAS, the matter was placed before ERC in its 303<sup>rd</sup> (Virtual) meeting held on 24<sup>th</sup> March, 2022 and the committee decided to issue final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 18.05.2022.
- **4. AND WHEREAS,** the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 333<sup>rd</sup> (virtual) meeting held on 27<sup>th</sup> September, 2023 and the Committee observed that:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in reference to the Final Show Cause Notice dated 09.04.2022 and the Committee observed that:

- The institution has not submitted the faculty list after the date of issue of SCN dated 09.04.2022.
- The institution has not submitted the Experience Certificate of the Principal.

- Affidavit on Rs. 100/- non-judicial stamp paper by the management regarding selection/appointment of faculty is not submitted by the institution.
- The institution has not submitted the additional information as per Clause 7(14), 8(6) 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations dated 28.04.2017.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

- **5.** Accordingly, withdrawal order was issued to the institution dated 19.10.2023.
- **6. AND WHEREAS**, the institution against the order of ERC, preferred an appeal before NCTE (HQ) under section 18 of NCTE Act, 1993 and the NCTE (HQ) *vide* its Order F.No.89-212/E-321707/2023 Appeal/15<sup>th</sup> Meeting,2023/APPLERC202314732/123196 dated 19.12.2023, remanded the matter back to ERC for recognition, decided as under:
- "After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to ERC with a direction to verify the submitted documents filed by the Appellant institution with Appeal from the records available with ERC and if it feel necessary and appropriate then documents may also be verified from the concerned competent authority. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time in terms of direction given herein above."
- **7. AND WHEREAS**, the matter was considered by the ERC in its 337<sup>th</sup> meeting of the ERC held on 09.01.2024 and the Committee decided as under:-

"The original file of the institution alongwith Appeal Order No F.No.89-212/E-321707/2023 Appeal/15<sup>th</sup> Meeting,2023/APPLERC202314732/123196 dated 19.12.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

• The Committee noted that the withdrawal order 19.10.2023 has already been set aside by the Appellate Authority vide its Order dated 19.12.2023 and remanded the case back to ERC for consideration, therefore. ERC decided that the recognition granted to the institution for running B.Ed. programme is restored until a fresh withdrawal order is issued by ERC. Order be issued accordingly.

The Committee further decided that the documents submitted by the institution in compliance of the appeal order be verified by the concerned competent authority and a copy of these communications may also be endorsed to the State Government.

8. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to Dulari Institute of Education Centre, Vill:- Manika Bishnunpur Chand, Street / Road:- Pusa Road, Taluka/ Mandal:- Mushahari, Town/City:- Manika Bishnunpur Chand, Dist:- Muzaffarpur, Bihar- 843119 for conducting B.Ed. programme of two year duration granted *vide* Order No. F. No. ERC/243.6.12/ B.El.Ed. & B.Ed./2017/Appl. Code No.ERCAPP201645176 Appl. ID. No. 9405/54620 dated 07.10.2017 for an annual intake of 100 students (two basic units) is hereby restored until a fresh withdrawal order is issued by ERC.
