ORDER

WHEREAS, Department of Physical Education, University of Kalyani, Kalyani, Nadia, West Bengal-741235 (APE00282) was granted recognition for B.P.Ed. course with an annual intake of 50 vide ERC's order dated 01.07.2005. Revised recognition order issued on 30.05.2015 for one basic unit of 100 students with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHEREAS, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and decided to withdraw recognition to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide F.No.ER-274.14.44/APE00282/B.P.Ed./2019/61305 dated 20.08.2019 to the institution.

3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No.89-382/E-136554/2019 Appeal/20th Mtg.-2020/4th September, 2020/94732 dated 02.11.2020 decided to remand back the case to ERC for revisiting the matter.

4. AND WHEREAS, the institution had failed to submit reply in response to Appeal order dated 02.11.2020 within stipulated period. The ERC in its 286th meeting held on 25th & 26th November, 2020 considered the matter and as decided, Show Cause Notice was issued on 24.02.2021 to the institution.

5. AND WHEREAS, the institution submitted reply vide letters dated 19.02.2021 received on 26.02.2021. The original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice, were carefully considered by ERC in its 290th meeting held on 3rd March, 2021 and the committee decided as under:-

“Restoration of recognition order for B.P.Ed. course with an annual intake of 100 with two sections of 50 each be issued.

6. NOW, THEREFORE, recognition withdrawn vide order No. ER-274.14.44/APE00282/B.P.Ed./2019/61305 dated 20.08.2019 to the institution viz. Department of Physical Education, University of Kalyani, Kalyani, Nadia, West Bengal-741235 (Code No. APE00282) for B.P.Ed. Course is hereby restored with an annual intake of 100 with two sections of 50 each.
