**ORDER**

**Change of Name of the Institution**

WHEREAS, Ratulia Secondary Teachers Training Institute, Panskura Vidyasagar Social Welfare Society Building, Vill.- Kanakpur, Po.- Naranda, Dist.- Purba Medinipur, West Bengal- 721139 (Code No. APE00573) was granted recognition for B.Ed. course of one year duration vide Order No.4070 dated 17.05.2010 with an intake of 100 from the academic session 2009-2010, followed by revised order vide No. 32487 dated 30.05.2015 for B.Ed. course of two year duration with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, institution has submitted representation along with relevant documents regarding Change of name from Ratulia Secondary Teachers Training Institute' to 'Panskura Teachers Training Institute.

AND WHEREAS, the ERC in its 290<sup>th</sup> (Part – 2) meeting held on 4<sup>th</sup> March, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply dated 12.02.2021 in response to show cause notice for change of name of the institution as well as shifting of premises, were carefully considered by ERC and the committee decided as under.

(i) The change of name of the college from 'Ratulia Secondary Teachers Training Institute' to 'Panskura Teachers Training Institute' is accepted".

4. NOW THEREFORE, permission is granted for change of name of the institution from "Ratulia Secondary Teachers Training Institute" to "Panskura Teachers Training Institute". Now, the institution may be run at the aforesaid name henceforth from the date of issue of this order.
