#### **ORDER**

WHEREAS, in terms of Section 14(3)(a) of the NCTE Act, 1993, the institution viz. Teachers Training College, Mirza, PO. – Mirza, PS.– Palasbari, Dist.—Kamrup (Rural), Assam-781125 (APE00462) was granted recognition for B.Ed. course of one year duration with an annual intake of 100 vide ERC order No.ERC/7-76.6(iii).6/2007/8163 dated 04.06.2007, followed by revised recognition order vide No.ERC/NCTE/APE00462/B,Ed.(Revised Order)/2015/31759 dated 20.05.2015 for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfillment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 267<sup>th</sup> meeting held on 10<sup>th</sup> 11<sup>th</sup> February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued vide No.F.3-3/Regulation/NCTE/ERC/2016-2019/59372 dated 21.02.2019 with direction to the institution to comply the following points within 21 days from the date of issue of the letter:
  - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
  - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
  - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. AND WHEREAS, the institution did not submit any reply of first show cause notice u/s 17 dated 21.02.2019. The ERC in its 279<sup>th</sup> Meeting held on 14<sup>th</sup>-16<sup>th</sup> February, 2020 considered the matter and decided that final show cause notice u/s 17 be issued to the institution. Accordingly, final show cause notice u/s 17 was issued vide No.ERC/279.68/APE00462/B.Ed./2020/62494 dated 02.03.2020 on the following grounds:
  - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
  - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
  - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - e. Confirmation on website updates of the institution with all details along with affidavit.
  - f. Certified copy of registered land document to be submitted.

- g. Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 4. AND WHEREAS, the institution had failed to submit any reply of final show cause notice u/s 17 dated 02.03.2020. The ERC in its 290<sup>th</sup> (Part-2) meeting held on 4<sup>th</sup> March, 2021 carefully considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and no reply received in response to show cause notice and following observations were made:
  - a. Two show cause notice dt.21.02.2019 and 02.03.2020 were issued to the institution on the following grounds:-
    - (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.

(ii) Approved building plan by the concerned competent Govt. Engineer/Authority.

(iii) Approved building completion certificate by the concerned competent Govt.

Engineer/ Authority.

(iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.

(v) Confirmation on website updates of the institutions with all details along with affidavit.

(vi) Certified copy of registered land document to be submitted.

- (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- b. No reply received from the institution till date.

Hence, recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

- 5. NOW THEREFORE, recognition granted to the institution viz. Teachers Training College, Mirza, PO. Mirza, PS.– Palasbari, Dist.—Kamrup (Rural), Assam-781125 (APE00462) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
- 6. FURTHER, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <a href="www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of the issue of the order.
