**ORDER**

WHEREAS, the institution viz. Diphu B.Ed. College, Diphu, Karbi Anglong, Assam-782460 was initially granted conditional recognition to B.Ed. course of one year duration with intake of 60 for the academic session 2000-2001 vide ERC Order No.F.7-13/2000-ERC/815 dated 04.04.2000, followed by order vide no.ERC/7-19/2001/656 dated 15.06.2001 granting recognition to B.Ed. course with annual intake of 40 from the academic session 2001-2002 subject to fulfillment of conditions mentioned therein.

2. AND WHEREAS, the ERC in its 33<sup>rd</sup> meeting held on 21.03.2003 decided that recognition granted to B.Ed. course be withdrawn. Accordingly, withdrawal order vide no.ERC/7-33(ER-33.8.1)/2003/629 dated March 26, 2003 was issued to the institution on the ground mentioned therein.

3. AND WHEREAS, the institution had preferred an appeal against the withdrawal order of ERC and the Appellate Authority vide order F.No.89-87/2003 Appeal dated August 25, 2003 accepted the appeal by reversing the withdrawal order of ERC, giving some more time to the institution to get the joint account towards endowment fund operationalised.

4. AND WHEREAS, permission granted for additional intake of 60, making total intake of 100 B.Ed. course of one year duration with an intake of 100 vide order no.ERC/AS-S/N-6/2004/14546 dated 05.12.2008 vide ERC, followed by revised recognition for B.Ed. course of two year duration from the academic session 2015-2016 with an intake of 100 (two basic units) vide order no.ERC/NCTE/AS-S/N-7/99/B.Ed.(Revised Order)/2015/31760 dated 20.05.2015 as per NCTE Regulations, 2014 subject to fulfillment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

5. AND WHEREAS, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> - 17<sup>th</sup> April, 2018 considered the matter and accordingly, Show Cause Notice u/s 17(1) was issued to the institution vide no.F.3-3/Regulation/NCTE/ERC/2016/(Assam)/56741(1-21) dated 20.04.2018, with direction to the institution to submit the following:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

6. AND WHEREAS, the institution did not submit any reply in response to show cause notice issued by ERC vide letter dated 20.04.2018. The ERC in its 280<sup>th</sup> Meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the case and accordingly, final show cause notice u/s 17 was issued on 05.03.2020 with direction to the institution to submit the following:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

7. **AND WHEREAS**, the institution had failed to submit any reply in response to show cause notice issued by ERC vide letter dated 05.03.2020. The ERC in its 290<sup>th</sup> (part-2) meeting held on 4<sup>th</sup> March, 2021 carefully considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and no reply received in response to show cause notice and following observations were made:

- a. Two show cause notice dt. 20.04.2018 and 05.03.2020 were issued to the institution on the following grounds:-
- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
  - (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
  - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - (v) Confirmation on website updates of the institutions with all details along with affidavit.
- b. No reply received from the institution till date.

Hence, recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

8. **NOW THEREFORE**, recognition granted to the institution viz. **Diphu B.Ed. College, Diphu, Karbi Anglong, Assam-782460 (AS-S/N-7/99)** for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

9. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of the issue of the order.
