#### <u>ORDER</u>

WHEREAS, Rajkumari Sanatombi Devi College of Education, A.T.Line, North A.O.C., Imphal East, Manipur- 795001 was granted recognition for M.Ed. Course of one year duration with an intake of 25 vide ERC's order No. ERC/7-47(ER-47.6.2)/2000/2275(1) dated 09.08.2004 followed by revised order No. F.ERC/NCTE/ERCAPE00250/M.Ed.(Revised Order)/2015/31784 dated 20.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup> -18<sup>th</sup> January, 2020 considered the matter and as decided, recognition granted to M.Ed. course of the institution was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.62144 dated 28.01.2020 from the academic session 2020-2021.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 28.01.2020. The Appellate Authority vide its Order No. 89-298/E-172636/2020 Appeal/4<sup>th</sup> Mtg.-2021/21<sup>st</sup> January, 2021/97581 dated 15.02.2021 concluded that appellant institution is required to submit to ERC within 15 days of the issued of appeal orders (i) original faculty list with approval letter of University, (ii) Building Plan and (iii) FDRs, Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- AND WHEREAS, the institution has submitted reply vide letter dt. 27.02.2021 received on 01.03.2021. The ERC in its  $290^{th}$  (Part -1) meeting held on  $3^{rd}$  March, 2021 considered the matter and as decided show cause notice to the institution. Accordingly, Show Cause notice dt. 10.03.2021 was issued to the institution.
- 5. **AND WHEREAS,** the institution has submitted reply vide letter dt. 18.03.2021 received on 30.03.2021. The ERC in its 292<sup>nd</sup> meeting held on 20<sup>th</sup> April, 2021 carefully considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice and Committee decided as under:-

Restoration of recognition order for M.Ed. course with an annual intake of 50 (one unit) be issued.

- 6. NOW THEREFORE, recognition withdrawn vide order dated 28.01.2020 to the institution viz. Rajkumari Sanatombi Devi College of Education, A.T.Line, North A.O.C., Imphal East, Manipur-795001 for M.Ed. course is hereby restored recognition with an annual intake of 50 students (one unit).
- 7. The terms and conditions of the order F.ERC/NCTE/ERCAPE00250/M.Ed. (Revised Order)/2015/31784 dated 20.05.2015 issued to the institution shall remain same.
