ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, the recognition was granted to Nabakrushna Choudhury College of Teacher Education, Angul, Odisha-759122 for conducting B.Ed. & B.Ed. Add. Intake programme *vide* Order No.ERC No.732 dated 31.05.1996 from the academic session 1996-97, 1997-98, 1998-99, 1999-2000, 2000-01, 2001-02,ERC/7-84.6(II).16/2008/10482 dated. 14.03.2008 from the academic session 2008-2009, ERC/7-169.11.12.9/NCTE/B.Ed.-Addl. intake/2014/24230 dated 24.02.2014 from the academic session 2014-15, followed by revised recognition Order No. F.ERC/NCTE/OR-S/E-7/96 & APE00754 & ERCAPP1857/B.Ed.(Revised Order)/2015/32768 dated 31.05.2015 from the academic session 2015-2016 with an intake of 200 students.

- 2. AND WHEREAS, recognition of the institution was withdrawn *vide* Order No.F.No.ER-278.40/OR-S/E-7/96, APE00754 & ERCAPP1857/B.Ed./2020/62147 dated 28.01.2020.
- 3. **AND WHEREAS**, the Appellate Authority *vide* Order No. F.NO.89-205/E-192006/2020/ Appeal/19th Meeting, 2021Appeal No.APPLERC202114070 dated 19.08.2021, decided as under:
- "...After perusal of the Memoranda of Appeal, affidavit, documents on record and submissions made during online presentation of the appeal case, Appeal Committee of the Council concluded to set aside the impugned order dated 28.01.2020, therefore, the institution is entitled to the benefits of recognition proportionate to the number of faculty as per NCTE Regulations, 2014 until a fresh withdrawal order is passed by the Regional Committee and remand back the case of Nabakrushna Choudhury College of Teacher Education, Hakimpada, Angul, Odisha to the ERC, NCTE, for necessary action as indicated above.
- **4. AND WHEREAS**, the institution filed W.P (C) No. 7260/2021 before the Hon'ble High Court of Delhi and the Hon'ble Court vide order dated 30.07.2021, passed an order as follows:-

"The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed the order of restoration should be issued within two weeks of the order of remand being communicated to the regional committee, or upon request of the concerned institution. This streamlined procedure would obviate the multiplicity of litigation which is being witnessed at present. Neither the Court for this purpose."

5. AND WHEREAS, in view of the of Court Order dated 30.07.2021 and an Appeal Order dated 19.08.2021, the matter considered by the ERC in its 295th(Virtual) meeting of the ERC held on 21.08.2021 and the Committee decided as under:

"Restoration of recognition order for B.Ed. course with an annual intake of 50 (one basic unit) be issued". Accordingly, Restoration Order was issued on dated 31.08.2021.

- **6. AND WHEREAS,** the institution preferred another appeal and the Appellate Authority *vide* Order No. F.NO.89-160/2022/11th Meeting, 2022Appeal No.APPLERC202214386 dated 16.01.2023, decided as under:
 - "...After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded that the appeal deserves to be allowed and the matter be remanded back to ERC. Further, ERC is hereby directed to issue a speaking order after consideration the documents submitted by the appellant institution and take an appropriate action with respect to NCTE Regulations, 2014 guidelines and amendment issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority".
- 7. **AND WHEREAS,** the institution has not submitted reply in response to Appeal Order No. F.No.89-160/2022/11th Meeting, 2022, Appeal No.APPLERC202214386 dated 16.01.2023. The matter was considered by the ERC in its 325th (Virtual) meeting of the ERC held on 24.04.2023 and the committee decided as under:-

The original file of the institution alongwith Appeal Order No. F.NO.89-160/2022/11th Meeting, 2022, Appeal No.APPLERC202214386 dated 16.01.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- The Committee noted that the order 28.01.2020 has already been set aside by the Appellate Authority vide its Order dated 19.08.2021 which was considered by ERC and restoration order dated 31.08.2021 was issued for 50 seats. The institution filed an appeal against restoration order wherein the Appeal Committee passed Order dated 16.01.2023 and remanded back to ERC for consideration. In compliance with the appeal order, ERC decided that the recognition granted to the institution for running 150 seats in B.Ed. programme is hereby restored. Order be issued accordingly.
- **8. NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. Nabakrushna Choudhury College of Teacher Education, Angul, Odisha-759122*vide* Order No. F.ERC/NCTE/OR-S/E-7/96 & APE00754 & ERCAPP1857/B.Ed.(Revised Order)/2015/32768 dated 31.05.2015 for B.Ed. programme with

an annual intake of 200 students (four units) is hereby restored subject to fulfillment of the condition as per NCTE Regulation, 2014 until a fresh withdrawal order is issued by ERC.
