ORDER

WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, the recognition was granted to St. Paul Institute of Education, Kohima, Nagaland-797001 for conducting D.El.Ed. programme of one year duration with an annual intake of 60 students *vide* Order No. No. 3840 dated 10.07.1997 from the academic session 1997-1998, followed by revised recognition order for D.El.Ed. programme of one year duration with an annual intake of 60 students from the academic session 1999-2000 *vide* Order No. No. F.7-10/99-ERC/9520 dated 18.06.1999 with 60 intake, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, recognition of the institution was withdrawn on dated 24.11.2022.

3. **AND WHEREAS**, the Appellate Authority *vide* its Order No.89-31/E-288842/2023 Appeal/3rd Meeting, 2023 APPLERC202314539/117427 dated 07.03.2023, decided as under:

The Committee Decided to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority.

4. **AND WHEREAS**, the representation dated 13.03.2023 received in ERC office on dated 20.03.2023. The matter considered by the ERC in its 325th (Virtual) meeting of the ERC held on 24.04.2023 and decided as under:-

*The original file of the institution alongwith Appellate Authority *vide* its Order No.89-31/E-288842/2023 Appeal/3rd Meeting, 2023 APPLERC202314539/117427 dated 07.03.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.*

*The Committee noted that the withdrawal order 24.11.2022 has already been set aside by the Appellate Authority *vide* its Order dated 07.03.2023 and remanded back to ERC for consideration, it is being reiterated that the ERC shall take an appropriate decision with respect to the outcome of the LPA 190/2021 & LPA 520/2022. Therefore, ERC decided that the recognition granted to the institution for running D.El.Ed. programme is hereby restored which will be the subject to outcome of the Special Leave Petition (SLP), if filed by NCTE (HQ) before the Hon'ble Supreme Court of India.*

5. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. St. Paul Institute of Education, Kohima, Nagaland-797001 vide Order No. vide Order No. No. F.7-10/99-ERC/9520 dated 18.06.1999 with 60 intake for D.El.Ed. programme is hereby restored. Subject to outcome of the Special Leave Petition (SLP), if filed by NCTE (HQ) before the Hon'ble Supreme Court of India and subject to fulfillment of the condition as per NCTE Regulations, 2014

Also order that a copy of this Order be published in the Official Gazette.
