### **ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Muktir Shiksha Sebashram, Plot No.-1180, 1181, Street/Road- College Road, Village-Kuchila, PO-Gobardanga, Tehsil/Taluka-Kuchila, Town/City-Gobardanga, Dist.-North 24 Parganas, West Bengal-743235 has applied for grant of recognition/permission to Muktir Shiksha College of Education, Plot No-1180, 1181, 1182, Vill-Kuchlia, P.O./Town/City-Gobardanga, Tehsil/Taluka-Kuchlia, District-North 24 Parganas, West Bengal-743235 for D.El.Ed. course online on 29.05.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 12.06.2015.

- 2. **AND WHEREAS**, the ERC in its 227<sup>th</sup> meeting held on 8<sup>th</sup>-10<sup>th</sup> December, 2016 considered the matter and accordingly, formal recognition order under clause 7(16) of the NCTE Regulation, 2014 for D.El.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2017-2018 was issued vide ERC Order No.ER-227.6.21/ERCAPP2926/D.El.Ed./2016/50713 dated 29.12.2016.
- 3. **AND WHEREAS,** the ERC in its 259<sup>th</sup> meeting held on 11<sup>th</sup>-12<sup>th</sup> August, 2018 observed on verification of records in light of NCTE Regulation 2014 that the institution was inadvertently granted recognition in D.El.Ed. course with two basic units i.e. 100 intake capacity from the academic session 2017-2018, though the institution submitted 11 approved faculty list instead of 16 and also in their affidavit on Rs. 100/- Non judicial stamp paper, the institution mentioned acceptance of one unit only. The Committee decided that recognition granted for second unit of D.El.Ed. course is withdrawn from the academic session 2018-2019. However, However, the admitted students in the 2017-2018 sessions will not be affected by this decision. A fresh recognition order under Clause 7(16) for D.El.Ed. programme with an intake 50 (one basic unit) with effect from the academic session 2018-2019 be issued to the institution. Accordingly, a fresh recognition order issued to the institution vide ERC Order No.ER-259.12.4/ERCAPP2926/D.El.Ed./2018/57809 dated 28.08.2018, followed by corrigendum vide No.ER-259.12.4/ERCAPP2926/D.El.Ed./2018/58110 dated 22.10.2018.
- 4. **AND WHEREAS**, the institution had preferred an appeal to the NCTE Hqrs. against the ERC's fresh recognition order dated 28.08.2018. The Appellate Authority vide its Order F.No.89-297/E-172650/2020 Appeal/4<sup>th</sup> Mtg.-2021/21<sup>st</sup> January, 2021/97577 dated 15.02.2021 decided that the case of appellant institution deserves to be revisited keeping in view the revised lists of faculty dated 20.07.2017 and 03.08.2018 submitted by appellant to ERC and the matter was remanded back to ERC for consideration.

- 5. **AND WHEREAS,** the ERC in its 290th meeting (Part-I) held on 03<sup>rd</sup> March, 2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.02.2021 and decided that recognition be granted to D.El.Ed. course for one additional unit (50 intake) under Clause 7(16) of the NCTE Regulations, 2014 from the academic session 2021-2022, thus making the total intake of 100 (two units).

  Accordingly, recognition order issued vide No.F.ER-290.26/ERCAPP2926/NCTE/D.El.Ed./2021/63705 dated 03.03.2021.
- 6. **AND WHEREAS,** being aggrieved, the institution filed court case in W.P. (C) 8770 of 2021 and the Hon'ble High Court of Delhi vide Order dated 24.09.2021 directed the ERC to issue an order of restoration of recognition in favour of the petitioner within one week from today instead of fresh recognition order issued dated 03.03.2021.
- 7. **AND WHEREAS,** the ERC in its 296<sup>th</sup> (Emergent) meeting held on 01<sup>st</sup> October, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the order dated 24.09.2021 passed by Hon'ble High Court of Delhi and the Committee decided as under:-

Restoration of recognition for additional intake of 50 withdrawn from the academic session 2018-2019 vide order no.57809 dated 28.08.2018 be issued making the total intake of 100 (two units).

- 8. NOW THEREFORE, recognition for additional intake of 50 withdrawn from the academic session 2018-2019 vide order no.57809 dated 28.08.2018 of the institution viz. Muktir Shiksha College of Education, Plot No-1180, 1181, 1182, Vill-Kuchlia, P.O./Town/City-Gobardanga, Tehsil/Taluka-Kuchlia, District-North 24 Parganas, West Bengal-743235 for D.El.Ed. Course is hereby restored making the total intake of 100 students (02 units).
- 9. The terms and conditions of the recognition order no.50713 dt. 29.12.2016 issued to the institution shall remain unchanged.
