#### **ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Kabiguru College of Education, Plot No.- RS3011, 3012, 3016, 3024, 3025, Vill.-Rahamatpur, PO.-Rahamatpur, Tehsil/Taluka-Tehatta, Town/City-Karimpur, Dist.-Nadia, West Bengal-741165 has applied for grant of recognition/permission to Kabiguru College of Education, Plot No.- RS3011, 3012, 3016, 3024, 3025, Vill.-Rahamatpur, PO.-Rahamatpur, Tehsil/Taluka-Tehatta, Town/City-Karimpur, Dist.-Nadia, West Bengal-741165 for B.Ed. course online on 28.09.2011 for one year duration and hard copy received by Eastern Regional Committee of NCTE on 03.10.2011.

- AND WHEREAS, the ERC in its 168th meeting held on 30th-31st January, 2014 2. considered the matter and accordingly, formal recognition order under clause 7(11) of the NCTE Regulation, 2009 for B.Ed. course of one year duration with an intake of 100 from the academic session 2014-2015 was issued vide ERC Order No.ERC/7-168.6.25/NCTE/B.Ed./2014/24417 dated 03.03.2014.
- AND WHEREAS, revised recognition order vide No.32285 dt.27.05.2015 issued for B.Ed. course of two years duration with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.
- AND WHEREAS, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup>-17<sup>th</sup> April, 2018 decided to 4. issue show cause notice under section 17(1) of NCTE Act, 1993 in compliance of revised recognition order, accordingly, SCN issued vide no.56750(1-29) on the grounds mentioned therein.
- AND WHEREAS, the ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup>-16<sup>th</sup> February, 2020 decided 5. to issue final show cause notice under section 17(1) of NCTE Act, 1993 for non-compliance first SCN, accordingly, SCN issued vide no.62420 dated 26.02.2020 to the institution on the grounds mentioned therein.
- AND WHEREAS, the ERC in its 282<sup>nd</sup> meeting held on 08<sup>th</sup>-09<sup>th</sup> July, 2020 considered 6. the original file of the institution along with other related documents. NCTE Act. 1993. Regulations and Guidelines issued by NCTE from time to time, representation dated 14.03.2020 received on 17.03.2020 and the Committee decided that recognition granted to B.Ed. course be withdrawn from the academic session 2021-2022. However, withdrawal order issued vide No.62831 dt. 24.07.2020 mentioning that recognition granted for B.Ed. course is hereby withdrawn from the academic session 2020-2021. Subsequently, corrigendum vide no.62957 dated 26.08.2020 issued to the institution that academic session 2020-2021 mentioned in the withdrawal order dated 24.07.2020 be read as academic session 2021+2022 G-7, Dwarka Sector 10 New Jelhi + 110075 n

- 7. **AND WHEREAS,** the institution had preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order No.89-188/E-165205/2020 Appeal/22<sup>nd</sup> Mtg.-2021/APPLERC202013730/106122 dated 26.11.2021 remanded back the case to ERC for revisiting the matter keeping in view the averments made by appellant that Bangiya Gramin Vikas Bank is included in the PNB sponsored bank list.
- 8. **AND WHEREAS,** the ERC in its 300<sup>th</sup> (Virtual) Meeting held on 28.12.2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal remand back order dated 26.11.2021, order dated 22.12.2021 in WPA 20572/2021 passed by the Hon'ble Calcutta High Court, representation from the institution and the Committee decided as under:

"Restoration of recognition order to the institution viz. Kabiguru College of Education, Plot No.-RS3011, 3012, 3016, 3024, 3025, Vill.-Rahamatpur, PO.-Rahamatpur, Tehsil/Taluka-Tehatta, Town/City-Karimpur, Dist.-Nadia, West Bengal-741165 for B.Ed. course with annual intake of 100 students (02 units) be issued."

- 9. NOW THEREFORE, withdrawal order dated 24.07.2020 followed by corrigendum dated 26.08.2020 issued to the institution viz. Kabiguru College of Education, Plot No.-RS3011, 3012, 3016, 3024, 3025, Vill.-Rahamatpur, PO.-Rahamatpur, Tehsil/Taluka-Tehatta, Town/City-Karimpur, Dist.-Nadia, West Bengal-741165 for B.Ed. course is hereby restored with annual intake of 100 students (02 units).
- 10. The terms and conditions of the revised recognition order no.32285 dt.27.05.2015 issued to the institution shall remain unchanged.
