WHEREAS Bankura Christian College, PO.- Bankura, Dist-Bankura, West Bengal-722101(APE00748) was granted recognition for conducting B.P.Ed. course with an intake of 50 vide ERC Order No. 102095 dated 28/02/2008 from the session 2008-2009, followed by revised order vide No.32298 dated 27/05//2015 with an annual intake of 50 to 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 279th meeting held on 14th -16th February, 2020, considered the matter and as decided to issue Show Cause Notice u/s 17(1) of NCTE, Act 1993. Accordingly, Final Show cause notice was issued on 26/02/2020 to the institution on the following grounds:-
 - (i) Certified copy of registered land document to be submitted.
 - (ii) Total built up area is not mentioned in the building plan submitted by the institution.
 - (iii) Original FDRs of Rs.5 lakh and Rs. 7 lakh to be submitted.
 - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
- 3. AND WHEREAS, the institution has not submitted the reply in response to final show cause notice dated 26.02.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-
 - (i) Final show cause notice issued on 26.02.2020 and no reply has been received as on date.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

4. NOW THEREFORE, recognition granted to the institution viz. Bankura Christian College, PO.-Bankura, Dist- Bankura, West Bengal-722101 (Code No. APE00748) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022.
