### **ORDER**

WHEREAS, Shikshan Mahavidyalaya CTE, Nagaon, Plot No.- 296, Street No.- 37 NH, Vill.- Nuagaon, P.O.- Nuagaon, Town/City- Nagaon, Tehsil/Taluka- Nagaon, Dist.-Nagaon, Assam- 782003 (Govt Sikshan Mahavidyalaya, Nagaon, Assam- 782001 (Code No. AS-S/E-11/96 & ERCAPP1949 & ERCAPP2659) was granted recognition for conducting B.Ed. course with an intake of 100 students for the academic session 1997-1998 vide ERC's order No. 2802(11) dated 12.02.1997. Further, another order was issued to the institution reduced from 100 to 60 vide ERC order No. 7148 dated 24.11.1998, followed by revised order dated 28.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 189<sup>th</sup> meeting held on 27<sup>th</sup> 28<sup>th</sup> May, 2015, considered the matter and decided to grant additional 40 intake in existing B.Ed. Course. As the institution has granted 60 intake earlier, now the total intake is 100 (two basic unit) from the academic session 2015-2016. Accordingly, a revised order issued to the institution vide ERC's No. F. No. ER-189.6.6 /APP1949/B.Ed.-Addl. Intake/2015/32662 dated 31.05.2015.
- 3. AND WHEREAS, the ERC in its 241<sup>st</sup> meeting (Part-2) held on 07<sup>th</sup> 08<sup>th</sup> June, 2017, considered the matter and decided to grant permission additional intake of 50 students (existing 100 intake + additional 50 intake), thus making the total intake of 150 students (three basic units) from the academic session 2018-2019 and the same was issued vide ERC's No. F. No. ER-241.6.23/ ERCAPP2659/B.Ed.-Addl. Intake/2017/53604 dated 20.06.2017.
- 4. **AND WHEREAS.** the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> 17<sup>th</sup> April, 2018 considered the matter and as decided to issue show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly, show cause notice was issued to the institution on 20.04.2018.
- 5. AND WHEREAS, the institution has submitted the reply dated 05/05/2018 and received in this office on 09.05.2018 in response to show cause notice dated 20.04.2018. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020 considered the matter and as decided to issue final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly, final show cause notice was issued to the institution on 26.02.2020 on the following grounds:
  - a) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - b) Approved building plan by the concerned competent Goyt. Engineer/Authority.

- c) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- d) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- e) Confirmation on website updates of the institutions with all details along with affidavit.
- f) Certified copy of Registered land document needs to be submitted.
- g) Certified copy of Fire Safety certificate duly signed by the Govt. competent authority to be submitted.
- 6. **AND WHEREAS**, the institution has submitted the reply dated 18.03.2020 and received in this office on 08.05.2020 in response to final show cause notice dated 26.02.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> & 18<sup>th</sup> September, 2020 and the committee decided as under:-
  - (i) The institution has submitted 10 teaching faculty against the requirement of 1 +22 for running three units of B.Ed. course as per Appendix-4 of Regulation, 2014/ Norms & Standards.
  - (ii) Total built up area mentioned in the Building Completion Certificate (BCC) is 3671.60, which is less as per Regulation-2014 Norms & Standards.
  - (iii) Building Plan (BP) submitted by the institution is in piece meal and is not legible.

Hence, the committee decided to reduce 02 units (100 intake) from 150 intake from the next academic session 2021-22.

7. NOW THEREFORE, recognition granted to the institution viz. Shikshan Mahavidyalaya CTE, Nagaon, Plot No.- 296, Street No.- 37 NH, Vill.- Nuagaon, P.O.-Nuagaon, Town/City- Nagaon, Tehsil/Taluka- Nagaon, Dist.- Nagaon, Assam- 782003 (Govt Sikshan Mahavidyalaya, Nagaon, Assam- 782001 (Code No. AS-S/E-11/96 & ERCAPP1949 & ERCAPP2659) for conducting B.Ed. Course is hereby reduced 02 units (100 intake) from 150 intake (Three basic units). Thus, the total annual intake of the institution remains 50 (One basic unit) from the next academic session 2021-2022.
