- 2. **AND WHEREAS**, the ERC in its 279^{th} held on $14^{th} 16^{th}$ February, 2020, considered the matter and as decided, final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly, Show Cause notice was issued on 06.03.2020 to the institution on the following grounds:
 - (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
 - (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
 - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - (v) Confirmation on website updates of the institutions with all details along with affidavit.
 - (vi) Certified copy of registered land document to be submitted.
 - (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 3. **AND WHEREAS**, the institution has submitted the reply dated 15.09.2020 and received in this office on 17.09.2020 through e-mail in response to final show cause notice dated 06.03.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-
 - (i) Building Completion Certificate (BCC) duly signed by the competent authority has not been submitted.

In view of the above, the Committee decided as under:

Hence, B.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.
