ORDER

WHEREAS, Maulana Azad National Urdu University, College of Teacher Education, Danishgahe Islamia High School, Muslim Education Society (Trust), School Lane, Hutton Road, Asansol, West Bengal - 713301 was granted recognition for B.Ed. in (Urdu) course with an intake of 100 from the academic session 2014-2015 vide ERC Order dated 20.02.2014, followed by revised order dated 30.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 278^{th} held on $16^{th} 18^{th}$ January 2020, considered the matter and as decided, final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly, Show Cause notice was issued on 28.01.2020 to the institution on the following grounds:
 - (i) Original list teaching faculty duly approved by the affiliating body to be submitted.
 - (ii) Approved Building Plan (BP) mentioning the khasra No./Plot No. and built up area not submitted.
 - (iii) Building Completion Certificate (BCC) in the prescribed proforma duly signed by the competent Govt. authority to be submitted.
 - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
 - (v) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE, Regulation, 2014.
- 3. AND WHEREAS, the institution has submitted the reply dated 18.02.2020 and received in this office on 21.02.2020 in response to final show cause notice dated 28.01.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-
 - (i) List of teaching faculty member (1+13) which is less against the requirement of 1+15 for offering two units of B.Ed. course as per Appendix-4 of NCTE Regulation, 2014.
 - (ii) Validity of Fire Safety Certificate has been expired on 04.01.2020.

In view of the above, the Committee decided as under:

Hence, B.Ed. (Urdu) Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
