 - (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
 - (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - (v) Confirmation on website updates of the institutions with all details along with affidavit.
 - (vi) Certified copy of registered land document to be submitted.
 - (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 3. AND WHEREAS, the institution has not submitted the ERC reply in response to the final show cause notice dated 03/03/2020. The original file of the institution along with other related documents, NCTE, Act.1993, Regulation & Guidelines issued by NCTE from time to time were carefully considered by ERC in its 284th meeting held on 17th 18th September, and the committee decided as under:-
 - (i) Final show cause notice issued on 03/03/2020 and no reply has been received as on date.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

4. NOW THEREFORE, recognition granted to the institution viz. Ananda Chandra College Department of Physical Education, PO.- Jalpaiguri, Dist.- Jalpaiguri, West Bengal- 735101. (Code No. APE00719) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022.
