ORDER

WHEREAS, Ananda Chandra College Department of Physical Education, PO.- Jalpaiguri, Dist. - Jalpaiguri, West Bengal- 735101 was granted recognition for conducting B.P.Ed. course with an intake of 50 vide ERC Order No. 16277 dated 04/05/2009 for the session 2009-2010, followed by revised order vide No.32488 dated 30/05/2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 279th meeting held on 14th -16th February, 2020, considered the matter and as decided to issue Show Cause Notice u/s 17(1) of NCTE, Act 1993. Accordingly, final show cause notice was issued on 03/03/2020 to the institution on the following grounds:-


- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.
- (vi) Certified copy of registered land document to be submitted.
- (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.

3. AND WHEREAS, the institution has not submitted the ERC reply in response to the final show cause notice dated 03/03/2020. The original file of the institution along with other related documents, NCTE, Act.1993, Regulation & Guidelines issued by NCTE from time to time were carefully considered by ERC in its 284th meeting held on 17th - 18th September, and the committee decided as under :-

- (i) Final show cause notice issued on 03/03/2020 and no reply has been received as on date.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

4. NOW THEREFORE, recognition granted to the institution viz. Ananda Chandra College Department of Physical Education, PO.- Jalpaiguri, Dist.- Jalpaiguri, West Bengal- 735101 (Code No. APE00719) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022.



5. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.




