College, Plot No.-1, Vill.-Ulda, P.O.-Dhelaitbamu, Tehsil/Taluka-Barabazar, Town/City-Barabazar, Dist.-Purulia, West Bengal-723127 for B.Ed. programme of two year duration with an intake of 100 students *vide* ERC Order No. ER-239.6.23 (Part-2)/ERCAPP2557/B.Ed./2017/52776 dated 02.05.2017 from the academic session 2017-2018, as per NCTE Regulations, 2014.

2. AND WHEREAS, further, in terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to Netajee Suthash Chandra Bose Institute of Education B.Ed. College, Plot No.-1, Vill.-Ulda, P.O.-Dhelaitbamu, Tehsil/Taluka-Barabazar, Town/City-Barabazar, Dist.-Purulia, West Bengal-723127 for D.El.Ed. programme of two year duration with an intake of 50 students *vide* ERC Order No. ER-239.6.24 (Part-2)/ERCAPP2544/D.El.Ed./2017/52685 dated 30.04.2017 from the academic session 2017-2018, as per NCTE Regulations, 2014.
