#### WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Swami Vivekanand B.Ed. College, Vill:- Simultala, Street/Road:- Chakai Road, Taluka/Mandal-Jhajha, Town/City -Simultala, Dist. - Jamui, Bihar - 811316 for conducting B.Ed. programme of two year duration with an annual intake 100 (two basic units) *vide* Order No. F. No. ERC/252.6.22/B.Ed. & D.El.Ed./2018/Appl. Code No. ERCAPP201646184 Appl. ID. No. 8227/56308 dated 03.03.2018 from the academic session 2018-2019, as per NCTE Regulations, 2014.

- **2. AND WHEREAS**, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284<sup>th</sup> meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the Show Cause Notice to the institutions which have been recognized without NET qualified teachers. Accordingly, SCN was issued to the institution on dated 28.09.2020. The reply of the institution was received in ERC on 02.12.2020.
- 3. AND WHEREAS, the matter was placed before ERC in its 303<sup>rd</sup> (Virtual) meeting held on 24<sup>th</sup> March, 2022 and the committee decided to issue final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 21.05.2022 & 16.09.2022.
- **4. AND WHEREAS,** the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 332<sup>nd</sup> (virtual) meeting held on 30<sup>th</sup> August, 2023 and the Committee observed that:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in reference to the Final Show Cause Notice dated 09.04.2022 and the Committee observed that:

- The institution has submitted photocopy of faculty list comprising (01 Principal + 16 Asst. Professor) dated 10.11.2020 which is not in the prescribed format.
- Date of joining of the faculty is not mentioned in the list so as to ascertain the eligibility of the appointed faculty as per applicable NCTE Regulations.
- The institution has not submitted the latest faculty list after the date of issue of Final SCN on 09.04.2022.

- The institution has not submitted a copy of experience certificate of principal as per NCTE Regulations, 2014.
- The institution has submitted a photocopy of the faculty list which is approved by the Registrar, but the seal is not readable.
- The institution's website is not operational.
- The institution has not submitted an Original Affidavit on Rs.100/- non-judicial stamp paper by the management & documents of individual faculty along with their educational qualification certificates/testimonials/NET/PhD/experience certificate.
- Original affidavit on Rs. 10/- non-judicial stamp paper in respect of appointed faculty in prescribed format not submitted.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

- 5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to Swami Vivekanand B.Ed. College, Vill:- Simultala, Street/Road Chakai Road, Taluka/Mandal Jhajha, Town/City Simultala, Dist. Jamui, Bihar-811316 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1), or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

7. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website <a href="www.ncte.gov.in">www.ncte.gov.in</a> within 60 days from the date of the issue of the order.
