## **ORDER**

WHEREAS, in terms of Section 14 (3)(a)/15 (3) (a) of the NCTE Act, 1993, recognition was granted to Post Graduate Training College for Physical Education, Bampur, North Parganas, West Bengal-743233 for conducting M.P.Ed. programme of two year duration with an annual intake of 30 vide Order No. ERC/7-73.6(a).3/2007/6241 dated 12.02.2007, followed by revised recognition order for M.P.Ed. programme of two year duration with an annual intake 2015-2016 of 40 students from the academic session vide Order No. F.ERC/NCTE/APE00225/M.P.Ed./(Revised Order)/ 2015/32388 dated 29.05.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, institution has submitted representation dated 21.07.2023 along with relevant documents for change of name of Institution from "Post Graduate Training College for Physical Education" to "Post Graduate Government Institute for Physical Education" with affiliating body from "Baba Saheb Ambedkar Education University" to "Bengal State University, Barasat".

**3. AND WHEREAS**, the matter was considered by the ERC in its 333<sup>rd</sup> (Virtual) meeting of the ERC held on 27.09.2023 and the committee decided as under:-

"The original file of the institution alongwith other related documents, correction deed of land documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that:

• The institution be permitted to change the name of institution as "Post Graduate Government Institute for Physical Education and the affiliating body as West Bengal State University, Barasat" for running its B.P.Ed. & M.P.Ed. programme."

4. NOW THEREFORE, in terms of decision of ERC, permission is hereby granted to Post Graduate Training College for Physical Education, Bampur, North Parganas, West Bengal-743233 to change its name from "Post Graduate Training College for Physical Education" to "Post Graduate Government Institute for Physical Education" with affiliating body from "Baba Saheb Ambedkar Education University" to "Bengal State University, Barasat" with immediate effect.
