ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Debnarayan Shiksha Sansthan, Plot No- 31, Street/Road – S.T. Road, Vill- Natagachhi, PO.- Beniabow, Tehsil/Taluka- Sonarpur, Town/City- Sonarpur, Dist- South 24 Parganas, West Bengal – 743613 has applied for grant of recognition to **Debnarayan Shisha Sansthan (B.Ed. College), Plot No- 31, Street No- S T Road, Vill- Natagachhi, PO- Beniabow, Tehsil/Taluka- Sonarpur, Town/City- Sonarpur, Dist- South 24 Parganas, West Bengal - 743613 (Code No. ERCAPP3399)** for additional intake in **B.Ed.** Course online 06.06.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 10.06.2015.

2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. AND WHEREAS, as per the decision of 220th ERC Meeting held on 10th -11th August 2016, formal permission order under clause 7(16) was issued vide No. ER-220.6.36/ERCAPP3399/(B.Ed.-additional Intake)/2016/49112 dated 30.08.2016 with an additional intake of 50 (one basic unit), (existing 100 intake + additional 50 intake), thus making the total intake of **150 (one hundred fifty)** from the academic session **2017-2018** to the institution.

4. AND WHEREAS, the ERC in its 225th meeting held on 16th -18th November, 2016 observed that inadvertently the permission order dated 30.08.2016 was issued in favour of the institution considering the letter of the Secretary (Acting), Faculty of Education, University of Calcutta dated 23.07.2015 as a NOC from the affiliating body. But, in fact, the letter is not a valid NOC which is a pre-condition and mandatory at the time of online application and submission of hard copy of application, but due to inadvertence and oversight, such unintentional error has been made by the committee in its 220th ERC Meeting. Accordingly, a show cause notice u/s 17 of NCTE Act, 1993 was issued to the institution vide letter No. 50097 dated 22.11.2016 and another letter was issued to the Registrar, The West Bengal University of Teachers Training, Education Planning and Administrative, Kolkata, West Bengal vide No. 50098 dated 22.11.2016, wherein requested not to affiliate this institution for additional unit of 50 intake and also not to permit to get the admissions in this course. The response of the University is awaited in this issue so far.

As per reply of the institution dated 24.12.2016 wherein NOC also produced therewith which was issued on 21.12.2016 by the Registrar, The West Bengal University of Teachers Training, Education Planning and Administrative, Kolkata, West Bengal i.e. after 15th July, 2015 and not accepted by the committee.

5. AND WHEREAS, the ERC in its 232nd meeting held on 7th – 8th February, 2016 considered the matter in detail and decided as under:

"The permission granted to the institution for B.Ed. (additional intake) of one unit from the academic session 2017-18 has been withdrawn and Order F.No.ER-220.6.36/ERCAPP3399/(B.Ed.-Addl. Intake)/2016/49112 dated 30.08.2016 shall be treated as null and void. The decision shall be communicated to the affiliating body to withdraw affiliation for this particular B.Ed. (additional intake) of one unit".

6. NOW, THEREFORE, grant of permission to **Debnarayan Shisha Sansthan (B.Ed. College), Plot No- 31, Street No- S T Road, Vill- Natagachhi, PO- Beniabow, Tehsil/Taluka- Sonarpur, Town/City- Sonarpur, Dist- South 24 Parganas, West Bengal - 743613** (Code No. ERCAPP3399) for additional intake in **B.Ed. Course of one unit from the academic session 2017-18** is hereby **withdrawn** in terms of section 17(1) of NCTE Act, 1993. **The total intake of the institution is 100 (two basic units) for B.Ed. course with immediate effect.**

7. Further, if the institution is not satisfied with the order, they can prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days from the date of issue of the order.
