**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993 AswiniSymadasi Memorial Trust, Plot No.-711, 712, Vill - Natna, P.O. - Natnapattabuka, Tehsil/Taluka- 87 Pattabukahuda, Town/City - Karimpur, Dist - Nadia, West Bengal- 741122 had applied for grant of recognition to **AdhirSaraswati College of Education, Plot No.-711, 712, Vill-Natna, P.O.- Natnapattabuka, Tehsil/Taluka- 87 Pattabukahuda, Town/City-Karimpur, Dist-Nadia, West Bengal-741122 (ERCAPP4274)** for the **B.Ed.** programme online on **30.06.2015** and hard copy received by Eastern Regional Committee of NCTE on **14.07.2015**.

2. **AND WHEREAS**, the ERC in its 289<sup>th</sup> meeting held on 15<sup>th</sup> February, 2021 decided that applied to B.Ed. course be refusal order under Section 14(3)(b) of NCTE Act, 1993. Accordingly, refusal order vide no.63659 dated 24.02.2021 was issued to the institution.


3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's refusal order dated 24.02.2021. The Appellate Authority vide its Order No.89-180/E-188777/2021 Appeal/18<sup>th</sup> Meeting, 2021 APPLERC202114047 dated 02.09.2021 remanded back the case to ERC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal, within 15 days of receipt of orders on the appeal.

4. **AND WHEREAS**, the institution had submitted representation dt.10.09.2021 received in this office on 15.09.2021.

5. **AND WHEREAS**, the ERC in its 302<sup>nd</sup> (Virtual) Meeting held on 28<sup>th</sup> February & 01<sup>st</sup> March, 2022 considered The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, direction of appellate authority were carefully considered by ERC and the Committee made following observations:-

"The institution is still deficient on the following grounds.

1. **The website of the institution not functional / updated as per rules and regulation of NCTE from time to time.**

Hence, Show Cause Notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit their reply alongwith supported documents accompanied with notarized affidavit of Rs. 100/- on Non-judicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of show cause notice."

Accordingly, Show Cause Notice issued to the institution on 08.03.2022.


6. **AND WHEREAS**, representation dated 03.03.2022 received on 21.03.2022 from the institution in reference to grounds of Show Cause Notice dated 08.03.2022. The ERC in its 303<sup>rd</sup> (Virtual) Meeting held on 24<sup>th</sup> March, 2022 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the Committee made following observations:-

1. **Formal Recognition order U/s 7(16) be issued to the Institution for B.Ed and D.El.Ed programme with annual intake of 100 Students (two Unit) each course from the academic session 2023-24.**

7. **NOW THEREFORE**, in exercise of the powers vested under Section 14/15 (3) (b) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants recognition to AdhirSaraswati College of Education, Plot No. -711, 712, Vill -Natna, P.O. - Natnapattabuka, Tehsil/Taluka - 87 Pattabukahuda, Town/City - Karimpur, Dist - Nadia, West Bengal-741122 for conducting B.Ed.programme of two-years duration with an intake of 100 (two basic units of 50 students each)from the academic session 2023-2024 under Clause 7(16) of NCTE (Recognition Norms Regulations, & Procedure) 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc., as applicable.

9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


10. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programmes applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- a. Sanctioned programmes along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c. Name of faculty members who left or joined during the last quarter;
- d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application;
- j. The institution shall be free to post additional relevant information, If it so desires.
- k. Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

12. The institution shall make available list of students admitted on its official website.

13. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.


