ORDER

WHEREAS, Exalt College of Education, Plot No.436-428, Vill-Kanauhali, Po-Kanauhali, Tehsil/Taluka-Garaul, Town/City-Mahua, Dist-Vaishali, Bihar-844101 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.21169 dated 10.10.2013 from the academic session 2014-2015, followed by revised recognition order vide No.32230 dt.27.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 283rd meeting held on 24th-25th August, 2020 decided that recognition granted to B.Ed. course be withdrawn from the academic session 2021-2022. Accordingly, withdrawal order issued vide No.63031 dt.15.09.2020.
- 3. AND WHEREAS, institution preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order No.89-274/ E-171335/ 2020 Appeal/ 6th Mtg.- 2021/ 22nd February, 2021/97925 dated 10.03.2021 remanded back the case to ERC with a direction to consider the approved staff list in the proforma as well as updated website information to be sent to them by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC the approved faculty list submitted in appeal and also their updated website information within 15 days of receipt of orders on the appeal.
- 4. AND WHEREAS, as per direction of the Appellate Authority institution submitted representation dt.23.03.2021 received on 24.03.2021. The ERC in its 292nd meeting held on 20th April, 2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 10.03.2021 were carefully considered by the ERC and Committee decided as under:-

Restoration of recognition order for B.Ed. course with an annual intake of 100 (two units) be issued.

- 6. NOW THEREFORE, withdrawal order dated 22.08.2019 issued to the institution viz. Exalt College of Education, Plot No.436-428, Vill-Kanauhali, Po-Kanauhali, Tehsil/Taluka-Garaul, Town/City-Mahua, Dist-Vaishali, Bihar-844101 for B.Ed. course is hereby restored permitting the total annual intake of 100 (two basic units).
- 7. The terms and conditions of the revised recognition order No.31955 dt.23.05.2015 issued to the institution shall remain unchanged.
