<u>ORDER</u>

WHEREAS, Satyapriya Roy College of Education, AA/287, Salt Lake, Sector-1, Kolkata West Bengal-700064 (Code. No APE00286) was granted recognition for B.Ed. with an annual intake of 100 from the academic session 2004-2005 vide ERC order No.1552(1) dated 13.05.2004, followed by revised Order issued vide No. 32243 dated 27.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 284^{th} meeting held on $17^{th} - 18^{th}$ September, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2021-2022. Accordingly withdrawal order was issued Vide ERC order No. ER-284.39/APE00286/B.Ed./2020/63126 dated 05.10.2020 to the Institution.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC order dated 05.10.2020. The Appellate Authority vide order No.F.89-275/E-175374/2020 Appeal/3rd Mtg.-2021/20th January, 2021/97379 dated 11.02.2021 remanded back the case to ERC with a direction to consider the documents to be submitted to them by the appellant and take necessary action as per the NCTE Regulations, 2014.

4. **AND WHEREAS**, the institution submitted reply its vide letter dated 07.11.2020 received on 04.12.2020. The original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 11.02.2021 were carefully considered by ERC in its 292nd held on 20th April, 2021 and decided as under:-

"Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued."

5. NOW, THEREFORE, recognition withdrawn vide order No. ER-284.39/APE00286/B.Ed./2020/63126 dated 05.10.2020 to the institution viz. Satyapriya Roy College of Education, AA/287, Salt Lake, Sector-1, Kolkata West Bengal-700064 (Code. No APE00286) for B.Ed. course is hereby restored recognition with an annual intake of 100 students (Two units).
