## ORDER

WHEREAS, College of Teacher Education, Mangaldai (Formerly: Mangaldai Teachers' Training College), Darrang, Assam-784125 was granted recognition for B.Ed. Course with an intake of 60 from the academic session 2001-2002 vide ERC Order No. 1502 dated 23.05.2001, followed by revised order vide No. 32142 dated 26.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
2. AND WHEREAS, the ERC in its $274^{\text {th }}$ meeting held on $15^{\text {th }}-16^{\text {th }}$ July, 2019 considered the matter and as decided, recognition granted to B.Ed. course of the institution was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No. 61431 dated 28.08 .2019 from the academic session 20202021.
3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 28.08.2019. The Appellate Authority vide its Order No. 89-154/E-180214/2020 Appeal/ $22^{\text {nd }}$ Mtg. $2020 / 9^{\text {th }}$ October, 2020/94497 dated 19.10.2020 rejected the appeal and confirmed the withdrawal order dt. 28.08.2019 of ERC.
4. AND WHEREAS, the institution has submitted representation vide Memo No. CTE/B.Ed./NCTE/4/pt-1/2019 dt. 10.03.2021 along with copy of order of Hon'ble Gauhati High Court for re-consideration of the matter. The ERC in its $292^{\text {nd }}$ meeting held on $20^{\text {th }}$ April, 2021 carefully considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the order dated 25.01.2021. passed by the Hon'ble Gauhati High Court in W.P.(C) No.220/2021 and Committee decided as under:-

Restoration of recognition order for B.Ed. course with an annual intake of 50 (one unit) be issued.
5. NOW THEREFORE, recognition withdrawn vide order dated 28.08 .2019 to the institution viz. College of Teacher Education, Mangaldai (Formerly: Mangaldai Teachers' Training College), Darrang, Assam-784125 for B.Ed. course is hereby restored recognition with an annual intake of 50 students (one unit).
