## ORDER

In terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Vivekananda Ramakrishna Mission B.Ed. College, Vill./Town – Pirpur, P.O. – Pirpur, Police Station – Uluberia, Dis. – Howrah, West Bengal, Pin Code – 711303 for B.Ed. course of two year duration with an intake of 100 students vide ERC Order No. F. ERC/7-79.5.7/2007/9406 dated 11.09.2007 follwed by revised recognition order for B.Ed course of two years duration with an intake of 100 students (two basic units) from the academic session 2015-2016 vide order No. ERC/NCTE/APE00803/B.Ed(Revished order)/2015/32255 dated 27.05.2015 and D.El.Ed course of two year duration with an annual intake of 100 students vide ERC order No. ER-233.6.19/ERCAPP4067/D.El.Ed/2016/51634 dated 09.03.2017 respectively.

2. AND WHEREAS, the representation of the institution dated 08.09.2022 for changing its name of institution from Vivekananda Ramakrishna Mission B.Ed. College to Vivekananda Mission B.Ed. College was placed before ERC in its 309<sup>th</sup> (virtual) meeting (part-2) held from 14.09.2022 to 15.09.2022 and the committee decided that :-

"The institution had filed W.P. No. IA. No.GA/1/2022 in CS 125/2022 before the Hon'ble High Court at Calcutta for changing the Name from Vivekananda Ramakrishna Mission B.Ed. College to Vivekananda Mission B.Ed. College. The Hon'ble High Court an Order dated 05.07.2022.

In compliance of the Court Order, a letter dated 16.08.2022 was issued to the institution as per decision taken by ERC in its  $307^{dh}$  meeting. The institution submitted its reply received in ERC office on 08.09.2022.

The Committee considered the reply submitted by the institution and decided that name of the institution be changed from Vivekananda Ramakrishna Mission B.Ed. College to Vivekananda Mission B.Ed. College.

The institution, State Government and the affiliating body concerned be informed accordingly".

3. NOW THEREFORE, in terms of above decision of ERC, change of name of the institution is hereby permitted from *Name from Vivekananda Ramakrishna Mission B.Ed. College to Vivekananda Mission B.Ed. College*.
