ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Vikram Deb Autonomous College, Jeypore, Vill- Jeypore, Street/Road- Near NH-26, Taluka/Mandal- Jeypore, Town/City- Jeypore, Dist- Koraput, Odisha-764001 for conducting B.Ed. programme of two year duration ER-250.6.35(Part-2)/App11012/B.Ed./2018/ 56240 dated 02.03.2018 from the academic session 2018-2019, as per NCTE Regulations, 2014.

- AND WHEREAS, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 2. 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284th meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the show cause notice to the institutions which have been recognized without NET qualified teachers. Accordingly, first SCN was issued to the institution on dated 05.10.2020. Reply dated 10.11.2020 & 18.03.2021 received on 18.11.2020 & 05.04.2021.
- AND WHEREAS, the matter was placed before ERC in its 303rd (Virtual) meeting 3. held on 24th March, 2022 and the committee decided to issue final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. No reply received from the institution in response to Final SCN dated 09.04.2022.
- 4. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 326th (virtual) meeting held on 23rd May, 2023 and the Committee observed that:
 - The institution has not submitted the reply of Final Show Cause Notice dated 09.04.2022 issued to it.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order. Accordingly, withdrawal order was issued to the institution on dated 08.06.2023.

5. **AND WHEREAS**, the institution preferred an appeal against the ERC withdrawal order dated 08.06.2023. The appeal *vide* Order No. F.No.-89-138/E-313002/2023 Appeal/9th Meeting, 2023/APPLERC202314630/121453 dated 12.09.2023, decided as under:

"Appeal Committee of the Council concluded to remand back the case to ERC with a direction to verify the faculty list submitted in appeal from the concerned Affiliating University and also at is liberty to verify other documents which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted from the concerned issuing authority"

6. AND WHEREAS, the institution representation received in ERC office on dated 22.09.2023 was considered by the ERC in its 333rd (Virtual) meeting of the ERC held on 27.09.2023 and the committee decided as under:-

The original file of the institution alongwith Appeal Order No. F.No.-89-138/E-313002/2023 Appeal/9th Meeting, 2023/APPLERC202314630/121453 dated 12.09.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

• The Committee noted that the withdrawal order 08.06.2023 has already been set aside by the Appellate Authority vide its Order dated 12.09.2023 and remanded the case back to ERC for consideration. Therefore, the ERC, on consideration of the reply submitted by the institution decided that the recognition granted to the institution for running B.Ed. programme is hereby restored.

Order be issued accordingly.

7. **NOW THEREFORE,** in terms of above decision of ERC, the recognition granted to the institution viz. **Vikram Deb Autonomous College, Jeypore, Vill- Jeypore, Street/Road-Near NH-26, Taluka/Mandal- Jeypore, Town/City- Jeypore, Dist- Koraput, Odisha-764001** *vide* **Order ER-250.6.35(Part-2)/App11012/B.Ed./2018/56240 dated 02.03.2018 for an annual intake of 100 students for two basic units is hereby restored.**
