**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, Acharya Sudarshan, Plot No. 1092, Street/Road- Aatm Kalyan Bhawan Behind Patna Central School, Vill-Jaganpura New By Pass Road, Po- New Jaganpur, Tehsil/Taluka- Phulwari Sharif, Town/City- Patna, Dist.- Patna, Bihar-800027 has applied for grant of recognition/permission to **Acharya Sudarshan B.Ed. College, Plot No. 1123, Street No. 49, Vill/Po- Mubarakpur, Tehsil/Taluka- Majorganj, Town/City- Mubarakpur, Dist.- Sitamarhi, Bihar-843332 (Code No.- ERCAPP3826)** for **D.El.Ed. programme** online on **29.06.2015** for two year duration and hard copy received by Eastern Regional Committee of NCTE on **11.07.2015**.

2. **AND WHEREAS**, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition/permission to **Acharya Sudarshan B.Ed. College, Plot No. 1123, Street No. 49, Vill/Po- Mubarakpur, Tehsil/Taluka- Majorganj, Town/City- Mubarakpur, Dist.- Sitamarhi, Bihar-843332** for conducting **D.El.Ed. programme** of two years duration with an intake of **50 (one basic unit)** from the academic session **2017-2018** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
