# • The Committee accepted the request of the institution vide letter dated 21.03.2023 for reduction in its annual intake of D.El.Ed. programme from 2 units (100 students) to 1 unit (50 students). Orders be issued accordingly.

NOW THEREFORE, in terms of decision taken by ERC, the annual intake of the institution namely Shyamapada Das College of Education, Plot No.-190, St. No.-Highway EX, Vill-Tentuldihi, P.O.-Chhamna, Tehsil/Taluka-Mayureshwar-II, Town/City-Suri, Dist.-Birbhum, West Bengal-731218 is hereby reduced from 2 units (100 students) to one unit (50 students) for running its D.El.Ed. programme subject to fulfilment of condition of NCTE Regulations 2014.
