ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Saheed Basudeo Teachers Training College, Plot No. 554/657, 658, 405/464, Vill/Po- Dhoraiya, Tehsil/Taluka- Dhoraiya, Town/City-Dhoraiya, Dist. Banka, Bihar-813224 was granted recognition for conducting DEl.Ed. programme of two year duration with an annual intake of 50 seats *vide* recognition Order No. ER-183.6./ ERCAPP1496/D.El.Ed./2015/30752 dated 03.03.2015 from the academic session 2015-2016, as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the institution submitted a letter No. SBTTC682/23 dated 25.03.2023 has requested to consider the prayer for closure of D.El.Ed. Programme.
- 3. AND WHEREAS, the matter placed before ERC in its 325th (Virtual) ERC Meeting held on 24th April, 2023 and the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:
 - The Committee accepted the request made vide letter No. SBTTC682/23 dated 25.03.2023 for surrendering the recognition granted to the institution vide ERC's Order No. ER-183.6/ERCAPP1496/D.El.Ed./2015/ 30752 dated 03.03.2015 for D.El.Ed. course. Orders be issued accordingly.
- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Eastern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Saheed Basudeo Teachers Training College, Plot No. 554/657, 658, 405/464, Vill/Po-Dhoraiya, Tehsil/Taluka- Dhoraiya, Town/City- Dhoraiya, Dist. Banka, Bihar-813224 for conducting D.El.Ed. Programme of two years duration with an annual intake of 50 students.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."
