WHEREAS, Thockchom Ibotombi Institute of Teacher Education and Training, Bishnupur, Manipur- 795126 (MP-S/N-3/2002- Appeal/2003) was granted recognition for B.Ed. course with an intake of 60 students from the academic session 2000-2001 dated 14.01.2000. Permission was granted to the institution vide ERC's order no. ERC/7-40(ER-40.6.2)/2003/3419 dated 12.12.2003 with an intake of 100 (Two basic units).

- 2. **AND WHEREAS**, Revised Recognition Order (RRO) was issued to the institution vide ERC order

 No. F. ERC/NCTE/MP-S/N-3/2002- Appeal/2003/B.Ed.(Revised Order)/2015/31786 dated 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS**, the ERC in its 275th meeting held on 15th 16th July, 2019 considered the matter and decided to reduce the intake from 100 (two basic units) to 50 (one basic unit) form the academic session 2020-2021. Accordingly, order was issued ERC's order No. F. No.ER-275.14.3/MP-S/N-3/2002- Appeal/2003/B.Ed./2019/61444 dated 28.08.2019 on following grounds:-

 1^{st} show cause notice u/s 17(1) issued on 10.05.2018, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-

- (i) Qualified faculty comprises 1+11 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course.
- (ii) Faculties at sl. No.12, 13, 14 & 15 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- 4. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 28.08.2019. The Appellate Authority vide its Order No.89-465/E-142477/2019 Appeal/3rd Mtg.-2020/31st January, 2020 dated 02.03.2020 concluded to remand back the case to ERC for revisiting the matter on receipt of the fresh list containing the names of 1+15 faculty duly qualified as per NCTE Regulation as amended in June, 2017.
