ORDER

In terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Kaushalya Ramadhar Educational Trust, Village- Ramgarh, Street/Road- Mamrejpur, Taluka/Mandal- Chenari, Town/City- Ramgarh, Distt- Rohtas, Bihar-821104 for B.Ed. course of two year duration with an intake of 50 students vide ERC Order No. ER-274.6.3/ID No.10614 (B.Ed & D.El.Ed) /2019/61134 dated 05.08.2019 from the academic session 2020-2021.

2. **AND WHEREAS**, the representation of the institution dated 29.07.2022 for changing its affiliating University for running one unit of B.Ed. programme from Veer Kunwar University, Ara, Bihar to Maulana Mazharul Haque Arabic & Persian University, Patna, Bihar was placed before ERC in its 309th (virtual) meeting (part-2) held from 14.09.2022 to 15.09.2022 and the committee decided that :-

- **Keeping in view of the NOCs given by both the Universities, request of the institution dated 29.07.2022 for changing its affiliating University for running one unit of B.Ed. programme from Veer Kunwar University, Ara, Bihar to Maulana Mazharul Haque Arabic & Persian University, Patna, Bihar is permitted.**
