#### Restoration of Recognition & Change of Premises

WHEREAS, Hills College of Teacher Education, 1st Floor, Takar Complex, Naharlagun, Dist.- Papumpare, Arunachal Pradesh-791110 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7.64.10.1/2006/441-447 dated 18.02.2006 from the academic session 2006-2007, followed by revised recognition order No. 31612 dt. 09.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-274.14.95/(APE00531)/B.Ed./2019/61337 dated 22.08.2019 from the academic session 2020-2021 to the institution.
- AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs, against the ERC's order dated 22.08.2019. The Appellate Authority vide its Order No. 89-386/E-136844/2019 Appeal/35th Mrg.-2019/25th November, 2019/86016 dated 13.12.2019 decided that the matter deserved to be remanded to the ERC with a direction to consider the approved faculty list to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the approved staff list submitted in appeal, within 15 days of receipt of orders on the appeal.
- 4. AND WHEREAS, the ERC in its 279th meeting held on 14th -16th February, 2020 considered the appeal order dated 13.12.2019 and decided to issue show cause notice. Accordingly, show cause notice u/s 17 was issued on 03.03.2020 to the institution.
- 5. AND WHEREAS, the ERC in its  $282^{nd}$  meeting held on  $8^{th} 9^{th}$  July, 2020 considered the reply at 09.03.2020 from the institution and decided to issue final show cause notice. Accordingly, final show cause notice u/s 17 was issued on 07.08.2020 to the institution.
- 6. AND WHEREAS, the institution has submitted its reply in response to scn dt. 07.98.2020 along with requisite documents along with the application for shifting of premises.
- 7. AND WHEREAS, the ERC in its 283rd meeting held on 24th 25th August, 2020 considered the matter and decided that VT be constituted under section 14 of the NCTE Act, 1993 to ascertain infrastructure and instructional facilities of the TEI for shifting of premises to the new address mentioned in the application "Hills College of Teacher Education, Vill-Lekhi, PO-Naharlagun, Tehsil/Taluka- Naharlagun, Town/City- Naharlagun, Dist-Papum Pare, Arunachal Pradesh-791110". Accordingly, inspection was conducted by the VT experts on 06.10.2020 & 07.10.2020.

- 8. AND WHEREAS, the ERC in its 287<sup>th</sup> meeting held on 14<sup>th</sup> December, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the committee decided as under:-
  - (i) Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.
  - (ii) Shifting of the institution to its new premises i.e. Hills College of Teacher Education, Vill Lekhi, PO Naharlagun, Tehşil/Taluka Naharlagun, Town/City Naharlagun, Dist.- Papum Pare, Arunachal Pradesh 791110 is permitted.
- 9. NOW THEREFORE, recognition of the Hills College of Teacher Education, 1st Floor, Takar Complex, Naharlagun, Dist.- Papumpare, Arunachal Pradesh-791110 (Code No. APE00531), withdrawn vide order No. 61337 dt. 22.08.2019, has been restored for conducting for B.Ed. course of two years duration with an annual intake of 100 (two basic units) and permission is granted to the institution to shift its new premises i.e. Hills College of Teacher Education, Vill-Lekhi, PO-Naharlagun, Tehsil/Taluka-Naharlagun, Town/City-Naharlagun, Dist-Papum Pare, Arunachal Pradesh-791110.
- 10. The terms and conditions of the order No. 31612 dt. 09.05.2015 issued to the institution shall remain same.
