ORDER

WHEREAS, Chatta Primary Teachers Training Institute, Plot No – 112, 118, 119, 120, 130, Vill – Khana Jn. Road, PO – Khana Jn., Dist – Bardhaman, West Bengal – 713141 (Code No. ERCAPP3789) was granted recognition for B.Ed. Course with an annual intake of 100 (two basic units) vide ERC Order No. 53016 dated 02.05.2017 from the academic session 2017-2018 as per NCTE Regulations, 2014.

2. AND WHEREAS, a complaint letter dated 02.02.2016 received against the institution. Accordingly, a letter dated 20.12.2018 & 08.02.2019 was issued to the institution to clarify the matter


3. AND WHEREAS, in response to ERC letter dated 20.12.2018 & 08.02.2019, the institution has submitted reply vide letter dated 16.02.2019 received in this office on 19.02.2019, which has placed before the ERC in its 282nd Meeting held on 08th – 09th July, 2020 and decided as under:-

- The Committee discussed the various complaint cases received against the Chatta Primary Teachers Training Institute, Khana Jn. Road, PO – Khana Jn., Dist – Burdwan, West Bengal – 713141 and decided to issue show cause notice under section 17(1) of the NCTE Act, 1993 to the institution on the following points (for both the courses):-

1. Certified copy of registered land documents to be submitted.
2. Originally notarised copy of Change of land use certificate issued from Land Revenue/concerned Govt. Department to be submitted.
3. Originally notarised copy of Non-encumbrance certificate in the name of institution/society issued from the Land Registering Authority to be submitted.
4. Notarised copy of approved building plan to be submitted.
5. Notarised copy Building completion certificate to be submitted
6. FDR for Rs 5L and 7L to be submitted.
7. Details of website
8. Approved faculty list to be submitted.

Accordingly, Show Cause Notice u/s 17(1) issued vide letter no.62898 dated 13.08.2020 giving 21 days to the institution to submit reply from the date of issue of show cause notice:

4. AND WHEREAS, the institution submitted the reply its letter dated 13.08.2020 & 28.08.2020 and received on 18.08.2020 & 01.09.2020, in response to Show Cause Notice dated 13.08.2020 and the original file of the institution along with other related documents, NCTE

Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 290th meeting held on 03rd March, 2021 and the committee decided as under:-

- i. Requisite information including list of approved faculty list is not uploaded/updated on the institutional website as per clause 7(14)(i) of NCTE Regulation, 2014

Accordingly, Final Show Cause Notice u/s 17 issued vide letter no.63859 dated 18.03.2021 giving 30 days to the institution to submit reply from the date of issue of show cause notice:

5. **AND WHEREAS**, the institution submitted the reply its letter dated 31.03.2021, 30.03.2021 & 09.04.2021 and received on 05.04.2021, 12.04.2021 & 12.04.2021 respectively, in response to Final Show Cause Notice dated 18.03.2021. The ERC in its 303rd ERC (Virtual) Meeting held on 24th March, 2022 which is confirmed in its 304th (Emergent) Meeting held on 11th April, 2022 and considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, reply in response to final show cause notice for B.Ed. course were carefully considered by ERC and the Committee made following observations:-

1. First show cause notice under section 17(1) issued dated 13.08.2020 for compliance of deficiencies for B.Ed. course.
2. Final show cause notice under section 17(1) issued dated 18.03.2021 for B.Ed. course on the following ground:
 - i. **Requisite information including list of approved faculty list is not uploaded/updated on the institutional website as per Clause 7(14)(i) of NCTE Regulation, 2014.**


The institution is still deficient on the following in light of NCTE Regulations 2014:

- i. **The institution failed to upload requisite information including list of approved faculty list on its website and update the institutional website as per Clause 7(14)(i) of NCTE Regulation, 2014.**

Hence, recognition granted to B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session 2022-2023. On withdrawal of recognition, the affiliation, if any granted under Clause 8(10) of NCTE Regulations, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to apply for counselling from the next academic session i.e. 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

Further, in case of D.El.Ed. course of the same institution, the Committee observed as under:

1. First show cause notice under section 17(1) issued dated 13.08.2020 for compliance of deficiencies for D.El.Ed. course.

The Committee decided that final show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution for D.El.Ed. course on the following ground:

- i. **Requisite information including list of approved faculty list is not uploaded/ updated on the institutional website as per Clause 7(14)(i) of NCTE Regulation, 2014.**

Hence, **Final Show Cause Notice** under Section 17(1) of the NCTE Act, 1993 be issued to the institution to submit their reply alongwith supported documents accompanied with notarized affidavit of Rs.100/- on Non-judicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of final show cause notice.

At this stage, the institution is not entitled to apply for counselling from the next academic session i.e. 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023 prior to grant of recognition by ERC NCTE.

6. **NOW THEREFORE**, recognition granted to **Chatta Primary Teachers Training Institute, Plot No – 112, 118, 119, 120, 130, Vill – Khana Jn. Road, PO – Khana Jn., Dist – Bardhaman, West Bengal – 713141 (Code No. ERCAPP3789)** for **B.Ed. Course** is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2022-2023. On withdrawal of recognition, the affiliation, if any granted under Clause 8(10) of NCTE Regulations, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to apply for counselling from the next academic session i.e. 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

7. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
