ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Sushant Teachers Training College, Plot No. 272, Village Road, Vill./Po.-Nunfara, Tehsil/Taluka-Bandra, Town/City-Muzaffarpur, Dist.-Muzaffarpur, Bihar-843115 was granted recognition for conducting D.El.Ed. programme of two year duration with an annual intake of 50 students vide order No. F.No.ER-218.6.48/ERCAPP2618/D.El.Ed./2016/48628 dated 29.07.2016 from the academic session 2017-2018.

2. **AND WHEREAS**, a Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on 05.08.2022 as per decision of 306th meeting of ERC held on 12th to 13th July, 2022 to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14)(i) of NCTE, Regulations, 2014 which is related to uploading information on the website, if the web site of the institution is not working.

3. **AND WHEREAS**, the matter was again placed before 311th meeting of ERC held on 11th Oct, 2022, and the case of the institutions which had not filled up the PAR was considered by the ERC in its 306th meeting held 12th & 13th July, 2022 and as per decision of the Committee, the Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14)(i) of NCTE, Regulations, 2014 which is related to uploading information on the website. The Committee decided that Final Show Cause Notice be issued before withdrawal of recognition under Section 17 of the NCTE Act, 1993 to submit reply within 15 days from the date of issue of Final Show Cause Notice. As per decision of ERC-NCTE, SCN was issued to the applicant institution on 28.10.2022.

4. **AND WHEREAS**, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in 313th (virtual) meeting by ERC and the Committee observed that:

- *“As per provision contained in Section 12 (j) & (k) of the NCTE Act, 1993, the institution was asked to fill up the Performance Appraisal report (PAR) for the academic session 2020-21, however, the institution has not filled up the same.*

- *Therefore, as per decision taken by ERC in its 306th meeting held on 12th to 13th July, 2022, Show Cause Notice under Section 17 (1) of NCTE Act, 1993 was issued to the institution for not filing PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14) of NCTE, Regulations, 2014 which is related to uploading information on the website, if the web site of the institution is not working.*
- *Further, as per decision taken by ERC in its 311th meeting held on 11th October, 2022, Final Show Cause Notice was issued to the institution for not submitting the reply of Show Cause Notice issued to it.*
- *The Committee further noted that the institution has not submitted the reply of Final Show Cause Notice.*

Hence, Committee decided that the recognition for D.El.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order. Accordingly, withdrawal order was issued on dated 24.11.2022.

5. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. Against the ERC's order dated 05.01.2023. The Appellate Authority vide its Order No.89-277/E-285160/2022 Appeal/3rd Meeting, 2023 APPLERC202214503/117519 dated 07.03.2023 decided to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority. It is being reiterated that the ERC shall take an appropriate decision with respect to the outcome of the LPA 190/2021 & LPA 520/2022.

6. **AND WHEREAS**, the institution has submitted the representation on dated 17.03.2023 received in ERC 22.03.2023. The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 328th (virtual) meeting held on 12th June, 2023 and the Committee observed that:

The original file of the institution alongwith Appellate Authority vide its Order No.89-277/E-285160/2022 Appeal/3rd Meeting, 2023 APPLERC202214503/117519 dated 07.03.2023, other related documents submitted by the institution, NCTE Act 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- *The Committee noted that the withdrawal order 24.11.2022 has already been set aside by the Appellate Authority vide its Order dated 09.02.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running D.El.Ed. programme is hereby restored. Order be issued accordingly.*

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. **Sushant Teachers Training College, Plot No. 272, Village Road, Vill/Po- Nunfara, Tehsil/Taluka- Bandra, Town/City- Muzaffarpur, Dist.- Muzaffarpur, Bihar- 843115** for running D.El.Ed. programme for 50 students (one unit) is hereby restored.
