WHEREAS, R S Teachers Training College, Plot No.-332, 333, 334, 338, 339, Street No.-239, Vill/Po- Katras Bazar, Tehsil/ Taluka-Baghmara, Town/City-Katras, Dist.-Dhanbad, Jharkhand-828114 (Code No. ERCAPP1178) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 20578 dated 31.08.2013, followed by revised order vide No. 32601 dated 31.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- AND WHEREAS, the ERC in its 279th held on 14th 16th February, 2020 considered the 2. matter and as decided, Final Show Cause Notice u/s 17(1) was issued on 06.03.2020 to the institution on the following grounds:
 - Certified copy of registered land document to be submitted. (i)
 - Faculty list duly signed by the concerned affiliating body is required to be (ii) submitted.
 - Original FDRs of Rs.5 lakh and Rs. 7 lakh to be submitted. (iii)
 - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
 - Requisite information of the institutional website has not updated as per clause (\mathbf{v}) 7(14)(i) of the NCTE Regulation, 2014.
- AND WHEREAS, the ERC in its 283rd meeting held on 24th 25th August, 2020 considered the matter along with the reply dated 07.03.2020 received in this office on 12.03.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:
 - a) There is a mismatch between faculty list submitted by the institution and details of the same uploaded in the institutional website.
 - b) Certified copy of the land document has not submitted.
 - c) Original list of teaching faculty duly approved by the concerned affiliating body has not been submitted.
 - d) Validity of fire safety certificate is expired on 23.03.2018.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
