WHEREAS, Ramnagar B.Ed. College, Plot No-512, 513, 515 Vill.-Depal, P.O.-Depal, Tehsil/Taluka-Ramnagar-II, Town/City-Ramnagar, Dist.- Midnapore, West Bengal-721453 (ERCAPP1482) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order dated 07.11.2013, followed by revised recognition order issued on 26.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS, the ERC in its 272nd meeting held on 30th – 31st May & 1st June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60695 dated 14.06.2019 from the academic session 2020-2021 to the institution.**


3. **AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-331/E-132032/2019 Appeal/9th Mtg.-2020/28th February, 2020/91522 dated 15/07/2020 remand back the case to ERC for revisiting the matter.**

4. **AND WHEREAS, the institution has submitted representation vide letter dated 04/08/2020 received in this office on 18/08/2019. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.07.2020, were carefully considered by ERC in its 283rd meeting held on 24th & 25th August, 2020 and the committee decided as under:-**

“Restoration of Recognition Order of B.Ed. course to be issued.

5. **NOW, THEREFORE, recognition withdrawn vide order no. 60695 dated 14.06.2019 to the institution viz. Ramnagar B.Ed. College, Plot No-512, 513, 515 Vill.-Depal, P.O.-Depal, Tehsil/Taluka-Ramnagar-II, Town/City-Ramnagar, Dist.- Midnapore, West Bengal-721453 (Code No. ERCAPP1482) for B.Ed. course is hereby restored.**


