WHEREAS, Jiaganj Institute of Education & Training, VIII.- Jiaganj, P.O.- Jiaganj, Dist.-Murshidabad, West Bengal - 742123 (Code No.APE00955) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC Order dated 23.07.2009, followed by revised recognition order issued on 26.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS,** the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60918 dated 27.06.2019 from the academic session 2019-2020 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 27.06.2019. The Appellate Authority vide order No.89-274/E-125458/2019 Appeal/26th Mtg.-2019/26th August,2019/82250 dated 26/09/2019 remanded back the case to ERC with a direction to consider the documents relating to appointment of Principal and FDRs to be sent to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents submitted in appeal, with originals thereof, wherever necessary within 15 days of receipt of orders on the appeal.
- 4. **AND WHEREAS,** the institution submitted reply dated 01.10.2019 received in this office 03.10.2019. The ERC in its 282^{nd} Meeting held on $8^{\text{th}} 9^{\text{th}}$ July, 2020 and decided, show cause Notice u/s 17was issued on 26.12.2019 to the institution on the following grounds:
 - a) Original list of members of faculty duly approved by the affiliating body need to be submitted.
 - b) Requisite information of the institutional website has not updated as per clause 7(14)(i0 of the NCTE Regulations, 2014.
- 5. **AND WHEREAS**, institution submitted reply vide letter dated 13.01.2020 and received in this office on 17.01.2020. The ERC in its 280th meeting held on 29th February & 1st March, 2020 and decided, final show cause notice was issued to the institution on 09.03.2020 on the following grounds:
 - a) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- 6. AND WHEREAS, the institution submitted reply dated 13.03.2020 and received in this office on 08.05.2020 in response to final show cause notice dated 09.03.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 283rd meeting held on 24th & 25th August, 2020 and the committee decided as under:-
 - Restoration of Recognition Order of B.Ed. course to be issued.
