## **ORDER**

WHEREAS, Rabindra Nazrul Smriti B.Ed. Educational Institute, Vill/PO – Hetampur, PS-Dubrajpur, Dist – Birbhum, West Bengal – 731124 (Code No.APE00686) was granted recognition for B.Ed. course with an intake of 100 vide ERC Order No. 9410 dated 11.09.2007, followed by revised order vide No.332157 dated 26.05.2015 an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. **AND WHERAS,** the ERC in its  $274^{\text{th}}$  meeting held on  $15^{\text{th}} - 16^{\text{th}}$  July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61302 dated 20.08.2019 from the academic session 2020-2021 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No.89-411/E-139111/2019 Appeal/5<sup>th</sup> Mtg.-2020/4<sup>th</sup> February,2020/90107 dated 11/03/2020 remanded back the case to ERC for revisiting the matter after the appellant submits required documents.

4. **AND WHEREAS,** the institution submitted reply dated 06.03.2020 received in this office 12.03.2020, which has placed before the ERC in its  $282^{nd}$  Meeting held on  $8^{th} - 9^{th}$  July, 2020 and decided, show cause Notice u/s 17(1) was issued on 24.07.2020 to the institution on the following grounds:

- a) Principal is not eligible who possess no M.Ed. and also a P.G. (Sanskrit) in School subject is 54.6%, which is not accepted as per Appendix-4 of Regulation-2014/Norms & Standards.
- b) Principal is overage.

5. AND WHEREAS, institution has submitted e-mail reply vide letter dated 24.07.2020 received in this office on 20.08.2020. The ERC in its  $283^{rd}$  meeting held on  $24^{th} - 25^{th}$  August, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under

"Restoration of Recognition Order of B.Ed. course to be issued".

6. NOW, THEREFORE, recognition withdrawn vide order dated 20.08.2019, Rabindra Nazrul Smriti B.Ed. Educational Institute, Vill/PO – Hetampur, PS-Dubrajpur, Dist – Birbhum, West Bengal – 731124 (Code No. APE00686) for B.Ed. course is hereby restored.
