ORDER

WHEREAS, Jyotirmoy School of Education, Plot No. 641, 620, Vill/Town/City-Sonarpur, Tehsil/Taluka- Kalikapur, P.O.- Champathi, Dist- South 24 Parganas, West Bengal -743330 (ERCAPP1083) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 31.08.2012, followed by revised recognition order issued on 30.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. AND WHERAS, the ERC in its 274th meeting held on 15th 16th July, 2019 considered the matter and as decided, recognition granted to the institution for B.Ed. course is reduced intake from 100 to 50 (one basic unit) vide order no. 61476 dated 02.09.2019 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019. The Appellate Authority vide order No.89-364/E-135672/2019 Appeal/33rd Mtg.-2019/21st November, 2019/85838 dated 05/12/2019 remanded back the case to ERC with a direction to consider the appellant's letter dt. 05/08/2019 and its enclosures and take further action as per the NCTE Regulations, 2014.
- 4. **AND WHEREAS**, the institution has submitted representation vide letter dated 05/08/2019 received in this office on 09/08/2019. The ERC in its 279th meeting held on 14th 16th February, 2020 considered the matter and as decided, Show Cause Notice was issued on 27/02/2020 to the institution.
- 5. AND WHEREAS, the institution has submitted reply vide letter dated 04/03/2020 received in this office on 11/03/2020. The ERC in its 282^{nd} meeting held on $8^{th} 9^{th}$ July, 2020 considered the matter and as decided, Final Show Cause Notice was issued on 22/07/2020 to the institution on the following grounds:
 - (i) Original list of teaching faculty duly approved by the concerned affiliating body to be submitted.
- 6. AND WHEREAS, the institution submitted reply vide letter dated 21/07/2020 received in this office on 03/08/2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 283rd meeting held on 24th & 25th August, 2020 and the committee decided as under:-

"Restoration of Recognition Order of B.Ed. course to be issued for another one unit (50 intake). Hence, the total 2 Units (100 intake) is permitted.
