**ORDER**

**WHEREAS, Dhemaji Post Graduate Training College, Dhemaji, Assam- 787057 (Code No. AS-S/E-7/96) was granted recognition for B.Ed. course with an intake of 60 from the academic session 1997-1998 vide ERC's order No. 2802 dated 12.02.1997.**

2. **AND WHEREAS, Revised Recognition Order (RRO) was issued to the institution vide ERC order No. F. ERC/NCTE/AS-S/E-7/96/B.Ed.(Revised Order)/2015/31872 dated 23.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.**

3. **AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter and as decided, recognition to B.Ed. Course was withdrawn u/s 17(1) vide order no. F.No.ER-274.14.30/(AS-S/E-7/96)/B.Ed./2019/61430 dated 28.08.2019 from the academic session 2020-2021 on the following grounds:-**

*1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 16.05.2019 and the institution is still deficient on the following grounds:-*

- (i) *Faculty list is not as per NCTE Regulations, 2014.*
- (ii) *Part-time/guest faculty are not accepted.*

4. **AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 28.08.2019. The Appellate Authority vide its Order No.89-406/E-138528/2019 Appeal/36<sup>th</sup> Mtg.-2019/26<sup>th</sup> November, 2019/86068 dated 13.12.2019 concluded to remand back the case to ERC for revisiting after the appellant submits required documentary evidence to them within 15 days of issue of Appeal order.**

5. **AND WHEREAS, the institution submitted reply vide letter dated 21.12.2019 received in ERC, NCTE on 30.12.2019. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the matter and as decided, Show Cause Notice was issued on 26.02.2020 to the institution on the following grounds:**

- (i) *Principal is not qualified as per NCTE Regulation, 2014.*
- (ii) *Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.*


6. **AND WHEREAS**, the institution submitted reply vide letter dated 13.03.2020 received in ERC, NCTE on 17.03.2020. The ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-

**Restoration of Recognition Order of B.Ed. course to be issued.**

7. **NOW THEREFORE**, recognition withdrawn vide order dated 28.08.2019 to the institution viz. **Dhemaji Post Graduate Training College, Dhemaji, Assam- 787057 (Code No. AS-S/E-7/96)** for B.Ed. course is hereby **restored**.

8. The terms and conditions of the order No. F. ERC/NCTE/AS-S/E-7/96/B.Ed.(Revised Order)/2015/31872 dated 23.05.2015 issued to the institution shall remain same.


