**ORDER**

WHEREAS, Dhubri Post Graduate Teacher Training College, Bidyapara, Dist.- Dhubri, Assam- 783324 (Code No. AS-S/N-13/2001) was granted recognition for conducting B.Ed. course of one year duration with an intake of 60 students from the academic session 2000-2001 vide ERC's order No. F.7-13/2000-ERC/859 dated 10.04.2000. Permission was granted to the institution vide ERC's orders No. ERC/7-26/2002/2107(7) dated 19.07.2002 with an intake of 100 students from the academic session 2002-2003.

2. AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 students from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/AS-S/N-13/2001/B.Ed.(Revised Order)/2015/31879 dated 23.05.2015, as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. AND WHEREAS, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> - 17<sup>th</sup> April, 2018 considered the matter and decided 1<sup>st</sup> Show Cause Notice. Accordingly, 1<sup>st</sup> Show Cause Notice was issued on 20.04.2018 to the institution on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

4. AND WHEREAS, the institution has failed to submit reply of Show Cause Notice within the stipulated period of 21 days. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> - 16<sup>th</sup> February, 2020 considered the matter and decided Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 06.03.2020 to the institution on the following grounds:-

- Points mentioned in the pt SCN.
- Certified copy of registered land document to be submitted.
- Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.

5. **AND WHEREAS**, the institution submitted reply vide letter dated 02.03.2020, received in ERC, NCTE on 09.05.2020. The ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and observed as under:-


- (i) *There is a mismatch of floor-wise and total built up area mentioned in Building Plan (BP) and Building Completion Certificate (BCC).*

*Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.*

6. **NOW THEREFORE**, recognition granted to the institution viz. **Dhubri Post Graduate Teacher Training College, Bidyapara, Dist.- Dhubri, Assam- 783324 (Code No. AS-S/N-13/2001)** for B.Ed. Course of two year duration with an annual intake of 100 students is hereby **withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2021-2022.**

7. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of the issue of the order.


