ORDER

Whereas, Dibakar Patnaik Institute of Advanced Studies in Education, Konishi, Berhampur, Ganjam, Odisha- 760003 (Code No. OR-SO/N-4/99) was granted recognition for conducting M.Ed. course of one year duration with an intake of 24 students from the academic session 2000-2001 vide order no. F.7-13/2000-ERC/835 dt. 06.04.2000.


2. And whereas, after the promulgation of the NCTE Regulations, 2014 a Revised Recognition Order (RRO) no. F. ER-189.12.1.3/M.Ed.(Revised Order)/2015/32666 dt. 31.05.2015 was issued for conducting M.Ed. course of two years duration with an annual intake of 50 students from the academic session 2015-2016, subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintenance & updation of the web-site of institution etc and to submit the compliance to the ERC.

3. And whereas, a public notice was uploaded on the ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Order issued on or before 31st May, 2015 to these institutions after the promulgation of the NCTE Regulations, 2014. The ERC in its 254th meeting held on 16th – 17th April, 2018 considered the matter and decided to issue Show Cause Notice and same was issued on 20.04.2018 to the institution on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

4. And whereas, the institution has failed to submit reply of Show Cause Notice within the stipulated period of 21 days. The ERC in its 277th meeting held on 19th – 20th December, 2019 considered the matter and decided to issue final Show Cause Notice and same was issued on 13.01.2020 to the institution on the following ground :-

- (i) No reply has been received against the first show cause notice issued on 20.04.2018.

And whereas, the institution has submitted reply vide letters dt. 17.01.2020 and 13.02.2020, received in the ERC, NCTE on 27.01.2020 and 21.02.2020 respectively. The ERC in its 280th meeting held on 29th February & 1st March, 2020 considered the original file of the institution alongwith other related documents in light of the NCTE Act, 1993, Regulations and Guidelines issued by the NCTE from time to time and observed as under:-

- (i) The institution has fulfilled all criteria as per NCTE Regulations, 2014 in compliance to final show cause notice issued on 13.01.2020. Hence, continuation of Revised Recognition Order (RRO) be issued.

6. And whereas, the ERC in its 283rd meeting held on 24th & 25th August, 2020 reviewed the matter and decided as under:-


- (i) The institution has submitted 1+7 teaching faculty against the requirement of 10 for running one unit of M.Ed. course as per Appendix-5 of Regulation-2014/Norms & Standards.
(ii) Out of 08, five lecturers appointed on part-time basis, which is not permissible.

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

7. Now therefore, the recognition granted to the institution viz. Dibakar Patnaik Institute of Advanced Studies in Education, Konishi, Berhampur, Ganjam, Odisha- 760003 (Code No. OR-SO/N-4/99) for conducting M.Ed. course of two year duration with an annual intake of 50 students is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the academic session 2021-2022.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of the NCTE Act, 1993 through "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.


