WITHDRAWAL ORDER

WHEREAS in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Renuka Debi Shikshak Shikshan Mahavidyalaya, Plot No.2, Vill - Ujirpur, P.O. - Barnia, Tehsil/ Taluka/ Town/ City - Tehatta, Dist - Nadia, West Bengal – 741156** for conducting B.Ed. course of two years duration with an intake of 50 students (One Basic Unit of 50 students each) from the academic session 2017-2018 vide Order No. F.No.ER-239.6.134(Part-4)/ERCAPP3952 /B.Ed./2017 /52795 dated 02.05.2017, as per NCTE Regulations, 2014.

2. **AND WHEREAS** complaint letter dated 01.08.2022 was received in the office of ERC against the existing teacher training institution regarding short comings/deficiencies of faculty, uploading of information on web-site, renewal of FDRs, Fire Safety Certificate, payment of salary to faculty and infrastructure & instructional facilities etc. as required under NCTE Regulations, 2014.

3. **AND WHEREAS** the aforesaid complaint was considered by ERC in its 307th (Virtual) meeting of ERC held on 05th Aug, 2022 and the committee decided that show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution before withdrawal of recognition. Accordingly, first show cause was issued to the institution & No reply submitted by the institution in response to the SCN:

4. **AND WHEREAS** the matter was considered by ERC in its 309th (Virtual) Meeting (Part-2) held on 14th and 15th September, 2022, and the committee decided that the Final Show Cause Notice be issued to the institution on the following grounds:

- As per decision taken by ERC in its 307th meeting, Show Cause Notice was issued to the institution; however, the institution has not submitted the reply of the Show Cause Notice.

5. **AND WHEREAS** the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 312th (virtual) meeting held on 17th Oct, 2022 and the Committee observed that:

- The institution has not submitted any reply of the Show Cause Notice dated 12.08.2022 and Final Show Cause Notice dated 22.09.2022 issued to it.

Hence, Committee decided that the recognition for B.Ed. Course be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

6. **NOWTHEREFORE**, in terms of above decision of ERC, the recognition granted to **Renuka Debi Shikshak Shikshan Mahavidyalaya, Plot No.2, Vill - Ujirpur, P.O. - Barnia, Tehsil/ Taluka/ Town/ City - Tehatta, Dist - Nadia, West Bengal - 741156** for B.Ed. Course vide Order No. F.No.ER-239.6.134(Part-4)/ERCAPP3952 /B.Ed./2017 /52795 dated 02.05.2017 is hereby withdrawn under section 17(1) of NCTE, Act, 1993 with effect from the end of academic session next following the date of communication of this withdrawal order.

7. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
