ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, DAV College of Teacher Education, Koraput, Plot No-445, Street No.- Ashoknagar, Vill. Kumbha ii, PO – Koraput, Tehsil/Taluka-Koraput, Town/ City –Koraput, Dist. Koraput, Odisha – 764020 (Code No. OR-S/E-17/96 & ERCAPP1865) was granted recognition for conducting B.Ed. course of one year duration with annual intake of 20 from the academic session 2014-2015 vide ERC's order F.No. ERC/7-169.11.12.17/NCTE/B.Ed.- Additional Intake/2014/24231 dated 24.04.2014, followed by Revised Recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Unit) from the academic session 2015-2016 *vide* order F.ERC/NCTE/OR-S/E-17/96 & ERCAPP1865/B.Ed.(Revised Order)/2015/32689 dated 31.05.2015 as per NCTE Regulation, 2014.

- **2. AND WHEREAS**, the ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and as decided, First Show Cause Notice u/s 17 was issued on 20.04.2018 to the institution on certain grounds.
- 3. **AND WHEREAS**, the institution has submitted reply dated 03.05.2018, received in ERC, NCTE on 07.05.2018. The ERC in its 271st meeting held on 24th 25th April, 2019 considered the reply and decided to issue Final Show Cause Notice and same was issued on 16.05.2019 to the institution on certain grounds.
- **4. AND WHEREAS,** the institution has submitted reply dated 22.05.2019 in response to show cause notice dt. 16.05.2019 received on 27.05.2019. The ERC in its 272^{nd} Meeting held on $30^{th} 31^{st}$ May & 1^{st} June 2019 considered the matter and as decided, Final show cause notice u/s 17 (1) was issued to the institution on 18.06.2019 on certain grounds.
- 5. **AND WHEREAS**, the institution has submitted reply dated 22.06.2019 in response to show cause notice dt. 18.06.2019 received on 27.06.2019. The ERC in its 274th Meeting held on 15th 16th July, 2019 considered the matter that 1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 18.06.2019 and the institution is still deficient on the following grounds:
 - i. Faculty list comprises 1+6 instead of 1+15 as per NCTE Regulation, 2014.

Recognition Granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021

- 6. **AND WHEREAS,** in terms of above decision of ERC, the recognition of the institution was withdrawn vide Order dated 08.08.2019.
- 7. AND WHEREAS, the institution has preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 05.08.2019 and the Appellate Authority passed order dated 27.02.2024, set aside the withdrawal order of ERC and remanded back the case to ERC with a direction to verify the submitted document field by the appellant institution with Appeal from the record available with ERC and if it feel necessary and appropriate then documents may also verified from the concerned complement authority. The Appellant institution is directed to forward to the ERC the documents submitted in appeal with in 15days from the receipt of order of the appeal and after

receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

8. AND WHEREAS, the institution has submitted documents vide reply dated 03.04.2024. The matter was placed in 343rd meeting of ERC held on 09.05.2024 and the Committee decided as under:

The original file of the institution alongwith Appeal Order No. File NO.89-72/E-299496/2023 Appeal/3rd Meeting, 2024 APPLERC202314577, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC. The ERC decided the following:-

•The Committee noted that the withdrawal order dated 28.09.2020 has already been set aside by the Appellate Authority and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running two years B.Ed. programme with an annual intake of 100 (Two Units) is restored until a fresh withdrawal order is issued by ERC.

Order be issued accordingly.

The Committee further decided the following:-

- Issue First SCN u/s 17 of NCTE Act 1993 to the institution on the following grounds:-
- Principal is not qualified
- Seven Assistant professor appointed are not qualified as they do not have M.Ed Degree".
- 9. NOW THEREFORE, in terms of above decision of ERC, the said recognition granted to the institution viz. DAV College of Teacher Education, Koraput, Plot No-445, Street No.-Ashoknagar, Vill. Kumbha ii, PO Koraput, Tehsil/Taluka-Koraput, Town/ City –Koraput, Dist. Koraput, Odisha 764020 vide Order No. F.No. ERC/7-169.11.12.17/ NCTE/B.Ed.- Additional Intake/2014/24231 dated 24.04.2014. followed by Revised Recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Unit) from the academic session 2015-2016 vide order F.ERC/NCTE/OR-S/E-17/96 & ERCAPP1865/B.Ed.(Revised Order)/2015/32689 dated 31.05.2015 is hereby restored until a fresh withdrawal order is issued by ERC.
