**ORDER**

**WHEREAS**, in terms of Section 14/15 of the NCTE Act, 1993, Gobindapur Sephali Memorial Primary Teachers Training Institute, Vill- Gobindapur, PO- Keleti, Tehsil/Taluka-Aushgram, Town/City- Guskara, Dist- Bradhaman, West Bengal- 713128 was granted recognition for B.Ed. programme of two year duration with an annual intake of 100 seats (two basic units) from the academic session 2017-2018 vide ERC Order No.F.No.ER-239.6.109(Part-4)/ERCAPP3851/B.Ed./2016/52941 dated 02.05.2017 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, a complaint letter dated 23.08.2022 & 06.09.2022 was received in the office of ERC against the institution.

3. **AND WHEREAS**, the aforesaid complaint was considered by ERC in its 309<sup>th</sup> (Virtual) meeting (Part-2) held on 14<sup>th</sup> and 15<sup>th</sup> September, 2022, and the committee decided that show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution on certain grounds.

4. **AND WHEREAS**, a Show Cause Notice was issued on dated 22.09.2022. The institution has submitted reply dated 20.10.2022 received in ERC on 03.11.2022.

5. **AND WHEREAS**, the matter was considered by ERC in its 332<sup>nd</sup> (Virtual) meeting held on 30<sup>th</sup> August, 2023, and the committee decided that final show cause notice under section 17(1) of NCTE Act, 1993 be issued to the institution on certain grounds. Accordingly, Final Show Cause Notice was issued to the institution dated 18.09.2023.

6. **AND WHEREAS**, the reply dated 25.09.2023 was considered by ERC in its 333<sup>rd</sup> (virtual) meeting held on 27<sup>th</sup> September, 2023 and the Committee decided as under:-

*“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered was considered by ERC and the Committee observed that:*

- *The institution has not submitted the valid Fire Safety Certificate issued by the competent government authority.*
- *The institution has not submitted the latest faculty list duly approved by the affiliating body as per NCTE Regulations, 2014.*
- *The institution website is [www.gsmptti.com](http://www.gsmptti.com) which is not maintained and updated as per clause 7(14), 8(6), 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations dated 28.04.2017.*

*Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.”*

7. **AND WHEREAS**, in terms of above decision of ERC, the recognition of the institution was withdrawn vide Order dated 19.10.2023.

8. **AND WHEREAS**, the institution has preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 19.10.2023 and the Appellate Authority passed order dated 01.04.2024, set aside the withdrawal order of ERC and remanded back the case to ERC with a direction to verify the Fire Safety Certificate submitted in appeal from the concerned competent authority. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above."

9. **AND WHEREAS**, the institution has submitted documents / reply dated 03.04.2024 received in ERC office on 15.04.2024. The matter was placed in 343<sup>rd</sup> meeting of ERC held on 09.05.2024 and the committed decided as under:

*"The original file of the institution alongwith Appeal Order No. File No. 89-222/E-323500/2023 Appeal/4<sup>th</sup> Meeting, 2024 APPLERC202314731 dated 01.04.2024, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC. The ERC decided the following :-*

- *The Committee noted that the withdrawal order dated 19.10.2023 has already been set aside by the Appellate Authority and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running two years B.Ed. programme with an annual intake of 100 (Two Units) until a fresh withdrawal order is issued by ERC. Order be issued accordingly.*

*The Committee further decided the following :-*

- *The faculty list submitted by the institution in compliance of the appeal order be forwarded to the concerned affiliating University for verification."*

10. **NOW THEREFORE**, in terms of above decision of ERC, the said recognition granted to the institution viz. **Gobindapur Sephali Memorial Primary Teachers Training Institute, Vill-Gobindapur, PO- Keleti, Tehsil/Taluka- Aushgram, Town/City- Guskara, Dist- Bradhaman, West Bengal- 713128** vide order No. F.No.ER-239.6.109 (Part-4)/ERCAPP3851/B.Ed./ 2016/52941 dated 02.05.2017 for B.Ed. programme of two year duration with an annual intake of 100 seats (two basic units) is hereby restored until a fresh withdrawal order is issued by ERC.
