ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Dinabandhu B.Ed. College, Plot No. 438, 451, Vill.-Ragunathpur, Po.-Paligram, Tehsil/Taluka-Mangalkote, Dist.-Bardhaman, West Bengal-713128 was granted recognition for B.Ed. programme of one year duration with an annual intake of 100 seats from the academic session 2012-2013 vide order No.ERC/7-139.6.5/NCTE/B.Ed./2012/3392 dated 19.08.2012, followed by revised recognition for B.Ed. programme of two year duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016 vide order No. F.ERC/NCTE/(ERCAPP687)B.Ed. (Revised Order)/ 2015/32607 dated 31.05.2015 as per NCTE Regulations, 2014.

2. AND WHEREAS, as per the decision of ERC in its 328th (Virtual) meeting held on 12th June, 2023, First Show Cause Notice under section 17 of NCTE Act, 1993 was issued to the institution on 23.06.2023 on certain grounds.

3. AND WHEREAS, the matter was considered by ERC in its 332nd (Virtual) meeting of ERC held on 30th August, 2023 and the committee decided that Final Show Cause Notice be issued to the institution for non-submission of reply to First SCN. Accordingly, Final Show Cause Notice was issued to the institution dated 18.09.2023.

4.. AND WHEREAS, the reply of SCN received in ERC office 25.09.2023 was considered by the ERC in its 333rd (Virtual) meeting held on 27.09.2023 and the Committee decided as under:-

The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered was considered by ERC and the Committee observed that:

- *The institution has not submitted the valid Fire Safety Certificate issued by the competent government authority.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

5. AND WHEREAS, in terms of above decision of ERC, the recognition of the institution was withdrawn vide Order dated 20.10.2023.

6. AND WHEREAS, the institution has preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 20.10.2023 and the Appellate Authority passed order dated 01.02.2024, set aside the withdrawal order of ERC and remanded back the case to ERC with a

direction to verify the Fire Safety Certificate submitted in appeal from the concerned competent authority. The Appellant institution was directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

7. **AND WHEREAS**, the institution has submitted reply/documents dated 06.02.2024 received in ERC office on 07.05.2024. The matter was placed in 343rd meeting of ERC held on 09.05.2024 and the committee decided as under:

"The original file of the institution alongwith Appeal Order No. File No. 89-221/E-323499/2023 Appeal/1st Meeting, 2024 APPLERC202314729/ 123837 dated 01.02.2024, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC. The ERC decided the following :-

- The Committee noted that the withdrawal order dated 20.10.2023 has already been set aside by the Appellate Authority and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running two years B.Ed. programme with an annual intake of 100 (Two Units) is restored until a fresh withdrawal order is issued by ERC. Order be issued accordingly.*

The Committee further decided the following :-

- The Fire Safety Certificate submitted by the institution in compliance of the appeal order be forwarded to the concerned authority for verification."*

8. **NOW THEREFORE**, in terms of above decision of ERC, the said recognition granted to the institution viz. **Dinabandhu B.Ed. College, Plot No. 438, 451, Vill.-Ragunathpur, Po.-Paligram, Tehsil/ Taluka-Mangalkote, Dist.-Bardhaman, West Bengal-713128** vide order No. F.ERC/ NCTE/ (ERCAPP687)B.Ed. (Revised Order)/2015/32607 dated 31.05.2015 for B.Ed. programme of two year duration with an annual intake of 100 seats (two basic units) is hereby restored until a fresh withdrawal order is issued by ERC.
